PURSUANT to section 61H of the Social Security Act 1964, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the Social Security (Rates of Accommodation Supplement) Order 1995.
 - (2) This order shall come into force on the 1st day of July 1995.
- 2. Increasing amounts of some accommodation supplements on and after 1 July 1995—Each provision of the Social Security Act 1964 specified in the first column of the Schedule to this order is hereby amended by omitting every expression set out opposite to it in the second column of that Schedule, and substituting in each case the expression set out opposite to it in the third column of that Schedule.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 July 1995, increases some maximum rates of accommodation supplements. The increased rates are-

For households with 3 or more persons in-

- (a) Auckland, the increase is from \$100 to \$115 weekly:
- (b) Wellington, the increase is from \$65 to \$85 weekly:
- (c) The rest of New Zealand, the increase is from \$55 to \$70 weekly:

For households with 2 persons in-

- (a) Auckland, the increase is from \$75 to \$85 weekly: (b) Wellington, the increase is from \$60 to \$65 weekly:
- (c) The rest of New Zealand, there is no increase:

- For households with 1 person in—

 (a) Auckland, the increase is from \$60 to \$70 weekly:

 (b) Wellington, the increase is from \$50 to \$60 weekly:
 - (c) The rest of New Zealand, the increase is from \$42 to \$45 weekly.
