PURSUANT to section 61H of the Social Security Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the Social Security (Rates of Benefits and Rate of Allowance) Order 1989.
- (2) This order shall be deemed to have come into force on the 1st day of April 1989.
- 2. Increasing rates of benefits and rate of allowance on and after 1 April 1989—Each provision of the Social Security Act 1964 specified in the first column of the Schedule to this order is hereby amended by omitting every expression set out opposite to it in the second column of that Schedule, wherever that expression occurs, and substituting in each case the expression set out opposite to it in the third column of that Schedule.

3. Revocation—The Social Security (Rates of Benefits) Order 1988* is hereby revoked.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order, which is deemed to have come into force on 1 April 1989, increases the rates of a number of benefits and the rate of an allowance.

The maximum rate of an orphan's benefit is increased by \$3.52 to \$78.22 a week.

The net rates of miners' benefits are increased by \$3.03 to \$129.26 a week in the case of a married miner and by \$3.63 to \$155.11 a week in any other case.

The net rate of a miner's widow's benefit is increased by \$3.63 to \$155.11 a week.

The rate of the special disability allowance payable to a married person for the purpose of defraying expenses arising from the hospitalisation of that person's spouse is increased by \$1 to \$22 a week.

The "hospital" rate of benefit payable to a long-term hospital patient is increased by \$1 to \$22 a week.
