### ORDER IN COUNCIL

THE QUEEN'S MOST EXCELLENT MAJESTY IN COUNCIL

PURSUANT to section 61H of the Social Security Act 1964 and to the Royal Powers Act 1983, Her Majesty the Queen, acting by and with the advice and consent of Her Executive Council, is pleased to make the following order.

## ORDER

- 1. Title and commencement—(1) This order may be cited as the Social Security (Rates of Benefits) Order 1986.
- (2) This order shall be deemed to have come into force on the 15th day of January 1986.
- 2. Increasing rates of benefits on and after 15 January 1986—Each provision of the Social Security Act 1964 specified in the first column of the Schedule to this order is hereby amended by omitting every expression set out opposite to it in the second column of that Schedule, wherever that expression occurs, and substituting in each case the expression set out opposite to it in the third column of that Schedule.
- **3. Revocation**—The Social Security (Rates of Benefits) Order (No. 2) 1985\* is hereby consequentially revoked.

#### **EXPLANATORY NOTE**

This note is not part of the order, but is intended to indicate its general effect.

This order increases the rates of widows', invalids', miners', domestic purposes, sickness, unemployment, and related emergency benefits on and after 15 January 1986. The rates of the benefits are increased by \$5.56 a week for unmarried persons and \$9.28 a week for married couples.

The rate of child supplement for the first child of a solo parent receiving a social security benefit is increased by \$3.72 to \$70.71 a week.

The rate of orphans' benefits is increased by \$2.74 to \$56.74 a week.
