## THE SECONDARY SCHOOLS REGULATIONS, 1924. AMENDMENT NO. 14.

Enacting authority: His Excellency the Governor-General in Council, Act pursuant to which the regulations were made: The Education Act, 1914.

Date on which the regulations were made: 22nd day of October, 1936, Date of notification in *Gazette*: 29th day of October, 1936.

## REGULATIONS.

1. These regulations may be cited as the Secondary Schools Regulations, 1924, Amendment No. 14.

2. These regulations shall be read together with and form part of the regulations made by Order in Council dated 5th May, 1924\* (hereinafter called the "principal regulations"), as amended from time to time by the amending regulations referred to in the Schedule hereto.

3. These regulations shall come into force on the 1st day of

November, 1936.

4. Clause 18 of the principal regulations is further amended by—

(1) Revoking subclause (5) and the provisoes thereto, and

substituting the following:-

"(5) The first increment receivable by any teacher under this clause shall be payable from the 1st day of February next following after the lapse of a period of six calendar months reckoned from the date of commencing duty, and thereafter he shall receive an annual increment on each succeeding 1st February until he reaches the maximum of the grade of salary for his position:"

(2) Adding the following subclauses:—

"(6) Notwithstanding anything in subclause (5) of this clause, any teacher classified in Grade C or a higher grade and occupying a position of Grade D on the staff of a school shall receive annual increments until the maximum salary for a Grade C position is reached. Any such teacher who has, on the 1st day of November, 1936, been receiving the maximum salary for a Grade D position for not less than twelve months shall, from the said 1st day of November, receive salary at the rate shown for the first subdivision of Grade C and from the 1st day of February, 1937, at the rate shown for the second subdivision of Grade C in Schedule III.

- "(7) No increment to salary shall be payable to any teacher whose work for the year preceding has not been approved for the purpose by the Director, acting on the report of the Inspectors.
- "(8) The increases in salary authorized by these subclauses shall not be payable until authorized by the Minister."
- 5. Clause 43 of the principal regulations is revoked, and the following substituted:
- "43. There shall be paid to the Board of Governors of each secondary school a grant for incidental expenses at an annual rate equal to two hundred pounds for each school under its control plus a capitation of two pounds per pupil on the roll as defined in clause 10 hereof."
