## THE STATE SERVICES SALARY ORDER 1977

### ORDER IN COUNCIL

At the Government House at Wellington this 7th day of June 1977

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the State Services Remuneration and Conditions of Employment Act 1969, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

### ORDER

**1. Title and commencement**—(1) This order may be cited as the State Services Salary Order 1977.

(2) This order shall be deemed to have come into force on the 11th day of October 1976.

**2. Maximum salary that an employing authority may prescribe**—For the purposes of section 18 (1) of the State Services Remuneration and Conditions of Employment Act 1969, the maximum salary that any employing authority may by determination prescribe shall be—

- (a) In respect of any period commencing on or after the 11th day of October 1976 and ending not later than the close of the 13th day of March 1977, \$16,829 a year:
- (b) In respect of any period commencing on or after the 14th day of March 1977 and ending not later than the close of the 14th day of May 1977, \$17,839 a year:
- (c) In respect of any period commencing on or after the 15th day of May 1977, \$19,556 a year.

**3. Maximum salary that the State Services Tribunal may prescribe**—For the purposes of section 32 (4) of the State Services Remuneration and Conditions of Employment Act 1969, the maximum salary that the State Services Tribunal may by order prescribe shall be—

- (a) In respect of any period commencing on or after the 11th day of October 1976 and ending not later than the close of the 13th day of March 1977, \$16,829 a year:

- (b) In respect of any period commencing on or after the 14th day of March 1977 and ending not later than the close of the 14th day of May 1977, \$17,839 a year:
- (c) In respect of any period commencing on or after the 15th day of May 1977, \$19,556 a year.

**4. Maximum salary that a Single Service Tribunal may prescribe—**For the purposes of section 44 (4) of the State Services Remuneration and Conditions of Employment Act 1969, the maximum salary that a Single Service Tribunal may by order prescribe shall be—

- (a) In respect of any period commencing on or after the 11th day of October 1976 and ending not later than the close of the 13th day of March 1977, \$16,829 a year:
- (b) In respect of any period commencing on or after the 14th day of March 1977 and ending not later than the close of the 14th day of May 1977, \$17,839 a year:
- (c) In respect of any period commencing on or after the 15th day of May 1977, \$19,556 a year.

**5. Revocation—**The State Services Salary Order 1976\* is hereby revoked.

#### EXPLANATORY NOTE

*This note is not part of the order, but is intended to indicate its general effect.*

This order, which is deemed to have come into force on 11 October 1976, specifies the maximum salary that may be prescribed under the State Services Remuneration and Conditions of Employment Act 1969 by an employing authority or the State Services Tribunal or a Single Service Tribunal.

This order makes three separate adjustments in the maximum salary.

The first adjustment of 3.5 percent relates to the period commencing with 11 October 1976 and ending with 13 March 1977. This adjustment arises from the half-yearly survey conducted by the Department of Labour in October 1976.

The second adjustment relates to the period commencing with 13 March 1977 and ending with 14 May 1977. This adjustment of 6 percent incorporates in the maximum the amount of the wage order made by the Wage Hearing Tribunal under regulation 16r (1) of the Wage Adjustment Regulations 1974.

The third adjustment, which comes into force on 15 May 1977, results from the general review of salaries and allowances made by the Higher Salaries Commission. This review was conducted as at 1 April 1976.
