THE STATE SERVICES SALARY ORDER 1978

ORDER IN COUNCIL

At the Government House at Wellington this 21st day of August 1978

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the State Services Conditions of Employment Act 1977, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the State Services Salary Order 1978.

(2) This order shall be deemed to have come into force on the 11th day of October 1977.

2. Maximum salary that an employing authority may prescribe— For the purposes of section 20 (1) of the State Services Conditions of Employment Act 1977, the maximum salary that any employing authority may by determination prescribe shall be \$22,431.

3. Maximum salary that the Public Sector Tribunal may prescribe— For the purposes of section 43 (4) of the State Services Conditions of Employment Act 1977, the maximum salary that the Public Sector Tribunal may by order prescribe shall be \$22,431.

4. Maximum salary that a Single Service Tribunal may prescribe— For the purposes of section 56 (4) of the State Services Conditions of Employment Act 1977, the maximum salary that a Single Service Tribunal may by order prescribe shall be \$22,431.

5. Cost of living allowance and interim special allowance absorbed— Each of the maximum salaries fixed by clauses 2 to 4 of this order includes1978/235

- (a) The amount of the cost of living allowance payable pursuant to regulation 34 of the Wage Adjustment Regulations 1974 as that regulation stood immediately before the commencement of the Wage Adjustment Regulations 1974, Amendment No. 13 (the effect of which regulation was preserved by regulation 8 (2) of the Wage Adjustment Regulations 1974, Amendment No. 13); and
- (b) The amount of the interim special allowance that was introduced in October 1977.

6. Revocation—The State Services Salary Order 1977* is hereby revoked.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order, which is deemed to have come into force on 11 October 1977, fixes the maximum salary that may be prescribed under the State Services Conditions of Employment Act 1977 by an employing authority or the Public Sector Tribunal or a Single Service Tribunal.

The amount of the cost of living allowance payable pursuant to regulation 34 of the Wage Adjustment Regulations 1974 (as it stood immediately before the commencement of the Wage Adjustment Regulations 1974, Amendment No. 13) is included within the maximum salaries set out in this order.

The maximum salaries fixed by this order also include the amount of the interim special allowance that was introduced in October 1977.
