**ORDER IN COUNCIL**

At Wellington this 4th day of May 1987

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Social Security Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

---

**ORDER**

**1. Title and commencement**—(1) This order may be cited as the Social Security (National Superannuation) Order 1987.

(2) Clauses 2 and 4 of this order shall be deemed to have come into force on the 14th day of October 1986.

(3) Clause 3 of this order shall be deemed to have come into force on the 14th day of April 1987, and apply in respect of national superannuation due on and after that date.

**2. Rates of national superannuation from 14 October 1986 to 13 April 1987**—The rates of national superannuation due in the period which commenced on the 14th day of October 1986 and ended with the 13th day of April 1987 shall be—

(a) In the case of a married couple both of whom are entitled to receive national superannuation, \$270.34 a week:

(b) In the case of an unmarried person, \$162.20 a week:

- (c) In the case of a married person whose spouse is not entitled to receive national superannuation—
- (i) If the spouse of the applicant is, in his or her own right, in receipt of a benefit under Part I of the Social Security Act 1964 or of an economic pension, war veteran's allowance, or war service pension under the War Pensions Act 1954, \$135.17 a week.
  - (ii) In any other case, \$162.20 a week.

**3. Rates of national superannuation on and after 14 April 1987**—The rates of national superannuation on and after the 14th day of April 1987 shall be—

- (a) In the case of a married couple both of whom are entitled to receive national superannuation, \$278.44 a week:
- (b) In the case of an unmarried person, \$167.06 a week:
- (c) In the case of a married person whose spouse is not entitled to receive national superannuation—
  - (i) If the spouse of the applicant is, in his or her own right, in receipt of a benefit under Part I of the Social Security Act 1964 or of an economic pension, war veteran's allowance, or war service pension under the War Pensions Act 1954, \$139.22 a week.
  - (ii) In any other case, \$167.06 a week.

**4. Revocation**—The Social Security (National Superannuation) Order (No. 2) 1986\* is hereby revoked.
