HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the State Services Remuneration and Conditions of Employment Act 1969, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

**1. Title and commencement**—(1) This order may be cited as the State Services Salary Order (No. 7) 1974.

(2) This order shall be deemed to have come into force on the 1st day of April 1972.

**2. Higher salaries**—(1) Commencing with the dates respectively shown in the headings of the columns in the Schedule to this order headed “Yearly Rate of Salary on and from 1 April 1972”, “Yearly Rate of Salary on and from 26 October 1972”, “Yearly Rate of Salary on and from 11 August 1973”, and “Yearly Rate of Salary on and from 11 February 1974”, the salaries set out in that Schedule in respect of the positions mentioned therein (being salaries exceeding the amount prescribed for the time being by an Order in Council under section 18 (1) of the State Services Remuneration and Conditions of Employment Act 1969) may be paid in respect of those positions.

(2) The increments that are payable shall in each case be annual increments.

**3. Revocation**—The Third Schedule to the State Services Salary Order (No. 3) 1974\* is hereby amended by revoking so much thereof as relates to the position of Chief Executive, Auckland Hospital Board.
