# THE SECONDARY SCHOOL TECHNICAL BURSARIES REGULATIONS 1977, AMENDMENT NO. 4

### ORDER IN COUNCIL

At Wellington this 11th day of August 1986

## Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

# REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Secondary School Technical Bursaries Regulations 1977, Amendment No. 4, and shall be read together with and deemed part of the Secondary School Technical Bursaries Regulations 1977\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 14th day after the date of their notification in the *Gazette*.
- **2. Interpretation**—(1) The principal regulations are hereby amended by revoking regulation 2, and substituting the following regulation:
  - "2. In these regulations, unless the context otherwise requires,—

- "'Agriculture subject' means agriculture or horticulture:
- "'Bursary' means a technical bursary awarded under these regulations:
- "'Home' does not include any place outside New Zealand; but in relation to any pupil who otherwise has no home in New Zealand, includes that pupil's usual place of residence in New Zealand:
- "'Nearest', in relation to any pupil, means closest to that pupil's home:
- " 'Workshop subject' means-
  - "(a) Engineering shopwork; or
  - "(b) Woodwork; or
  - "(c) Workshop technology; or
  - "(d) Any subject recognised by the Director-General as a subject similar to any of those subjects."
- (2) Regulation 9 of the principal regulations is hereby amended by omitting the words "his nominated course", and substituting the words "the subject concerned".
- (3) Regulation 11 of the principal regulations is hereby amended by omitting the words "paragraph (b) of", in both places where they appear.
- (4) Regulation 14 of the principal regulations is hereby amended by omitting the words "pursue a nominated course", in both places where they appear, and substituting, in each case, the words "obtain instruction in the subject concerned".
  - (5) Regulation 19 of the principal regulations is hereby amended—
  - (a) By omitting from paragraph (b) the words "varies his course of instruction without permission", and substituting the words "without the prior approval of the Director-General varies his course of instruction"; and
  - (b) By omitting from paragraph (c) the words "pupil's nominated course", in both places where they appear, and substitution, in each case, the words "subject concerned".
  - (6) The Schedule to the principal regulations is hereby revoked.
- **3. Award of bursaries**—The principal regulations are hereby amended by omitting the words "bursary to any pupil eligible to receive the bursary to enable him to pursue a nominated course", and substituting the words "technical bursary to any pupil eligible to receive it, to enable him to obtain instruction in an agriculture subject or a workshop subject".
- **4. Classes of technical bursary**—The principal regulations are hereby amended by revoking regulation 5, and substituting the following regulation:
- "5. (1) There shall be 2 classes of technical bursary, junior bursaries and intermediate bursaries; and, subject to subclause (2) of this regulation, bursaries of each class may be awarded to enable pupils to study agriculture subjects or workshop subjects.
- "(2) A junior bursary may be awarded only to enable a pupil to study at Form 4 level; and an intermediate bursary shall be awarded only to enable study at Form 5 level."

- **5. New regulations substituted**—The principal regulations are hereby amended by revoking regulations 6 to 8, and substituting the following regulations:
- "6. **Eligibility for junior bursary**—A pupil shall be eligible to receive a junior bursary if—
  - "(a) Either-
    - "(i) He wishes to obtain instruction in an agriculture subject (hereafter in this regulation referred to as the subject concerned), but is unable to obtain instruction in any agriculture subject at the nearest State secondary school that, in the opinion of the Director-General, he could reasonably be expected to attend; or
    - "(ii) He wishes to obtain instruction in a workshop subject (hereafter in this regulation referred to as the subject concerned), but is unable to obtain instruction in any workshop subject at the nearest State secondary school that, in the opinion of the Director-General, he could reasonably be expected to attend; and
  - "(b) In order to obtain instruction in the subject concerned at a State secondary school he would be obliged to live away from home; and
  - "(c) He proposes to attend a school recognised by the Director-General for the purpose of giving instruction in agriculture subjects or workshop subjects (as the case requires) to bursars under these regulations; and
  - "(d) He has completed one year of secondary education to a standard approved by the Director-General for the purposes of this regulation; and
  - "(e) The principal of the school he attends (or last attended) recommends that he has sufficient ability to complete his proposed course of study satisfactorily.
- "8. Eligibility for intermediate bursary—A pupil shall be eligible to receive an intermediate bursary if—
  - "(a) He wishes to obtain instruction in an agriculture subject or a workshop subject, but is unable to obtain instruction in it at the nearest State secondary school that, in the opinion of the Director-General, he could reasonably be expected to attend; and
  - "(b) In order to obtain instruction in the subject at a State secondary school, he would be obliged to live away from home; and
  - "(c) He proposes to attend a school recognised by the Director-General for the purpose of giving instruction in agriculture subjects or workshop subjects (as the case requires) to bursaries under these regulations; and
  - "(d) He has completed 2 years of secondary education—
    - "(i) To a standard approved by the Director-General for the purposes of this regulation; and
    - "(ii) That, in the opinion of the Director-General, is relevant to the subject; and

"(e) He will not attain, or had not attained, the age of 17 years before the 15th day of January in the year in which he proposes or proposed to commence instruction in the subject."

### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations have 2 main effects. First, they provide that commerce, art, homecraft, and animal husbandry are no longer to be subjects for which secondary school technical bursaries may be awarded, and that such bursaries may now be awarded for workshop technology. Secondly, they make clear that where a pupil applies for a junior bursary in respect of a subject from the group of agriculture subjects or workshop subjects, he or she will not be eligible unless none of the subjects in that group is available locally.
