

## THE SALES TAX DISTRICTS ORDER 1952

PURSUANT to the Sales Tax Act 1932–33, the Minister of Customs hereby makes the following order.

## ORDER

1. (1) This order may be cited as the Sales Tax Districts Order 1952.

(2) This order shall come into force on the 1st day of February 1953.2. (1) The districts specified in the Schedule hereto are hereby

appointed to be districts for the purpose of collecting sales tax.

(2) Each of those districts shall comprise the counties specified in that behalf in the Schedule hereto, together with all boroughs and town districts which are within the outer boundaries of those counties or are bounded by those counties or are between those counties or any part thereof and the sea.

**3.** The place for the payment of sales tax in each of those districts shall be the place specified in that behalf in the Schedule hereto:

Provided that with respect to goods liable to sales tax under paragraph (c) of subsection (1) of section 11 of the Sales Tax Act 1932-33 (being goods imported into New Zealand and entered for home consumption under the Customs Act 1913 otherwise than by a licensed wholesaler for sale by him) the following special provisions shall apply:—

- (a) Where the goods are entered for home consumption at the port of Tauranga, sales tax shall be payable at the Customhouse at that port:
- (b) Where the goods are imported by post and are entered for home consumption, or deemed to be so entered, at any post office, sales tax shall be payable at that post office.

### EXPLANATORY NOTE

[This note is not part of the order, but is intended to indicate its general effect.]

This order replaces the Sales Tax Districts Order 1951. The only change is that, as a consequence of the closing of Westport as a port of entry under the Customs Act 1913, the order provides for the inclusion of the Buller and Murchison Counties in the Greymouth District as from the end of January 1953.
