THE SALES TAX DISTRICTS ORDER 1966

PURSUANT to the Sales Tax Act 1932-33, the Minister of Customs hereby makes the following order.

ORDER

1. (1) This order may be cited as the Sales Tax Districts Order 1966.
 (2) This order shall come into force on the day after the date of its notification in the *Gazette*.

2. (1) The districts specified in the Schedule hereto are hereby appointed to be districts for the purpose of collecting sales tax.

(2) Each of those districts shall comprise the counties or parts of counties specified in that behalf in the Schedule hereto, together with all cities, boroughs, and town districts which are within the outer boundaries of those counties or parts of counties or are bounded by those counties or parts of counties or are between those counties or any part thereof and the sea.

3. The place for the payment of sales tax in each of those districts shall be the place specified in that behalf in the Schedule hereto:

Provided that where goods liable to sales tax under section 11 (1) (c) of the Sales Tax Act 1932-33 (being goods imported into New Zealand and entered for home consumption under the Customs Act 1913 otherwise than by a licensed wholesaler for sale by him) are imported by post and are entered for home consumption, or deemed to be so entered, at any post office, sales tax shall be payable at that post office.

4. The Sales Tax Districts Order 1962*, and the Sales Tax Districts Order 1962, Amendment No. 1†, are hereby revoked.
