PURSUANT to section 15 of the Sales Tax Act 1974, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Sales Tax Exemption Order 1979, Amendment No. 11, and shall be read together with and deemed part of the Sales Tax Exemption Order 1979* (hereinafter referred to as the principal order).

(2) This order shall come into force on the 1st day of December 1981.

2. Goods exempted from sales tax—(1) Goods of the classes or kinds specified in the Schedule hereto are hereby exempted from sales tax.

(2) The First Schedule to the principal order is hereby amended by revoking item 116, and substituting the items 116, 116A, and 116B specified in the Schedule hereto.

EXEMPTIONS FROM SALES TAX

Item No.	Goods
116	Goods of classes included in Annex B, and Annex C Item (v) of the UNESCO Agreement on the Importation of Educational, Scientific and Cultural Materials when imported by or for, or sold to, educational, scientific, or cultural institutions approved by the Minister for their own use, and under such conditions as the Minister may determine.
116A	Goods of classes included in Annex A, and Annex B Item (i) of the Protocol to the UNESCO Agreement on the Importation of Educational, Scientific and Cultural Materials; and goods of a class included in Annex B Item (ii) of the Protocol to the UNESCO Agreement on the Importation of Educational, Scientific and Cultural Materials as may be approved by the Minister.
116B	Goods of classes included in Annex B Item (iii) and Annexes C.2, D, E, and G of the Protocol to the UNESCO Agreement on the Importation of Educational, Scientific and Cultural Materials when imported by or for, or sold to, institutions approved by the Minister and under such conditions as the Minister may determine.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order provides for the extension of the exemption for goods covered by the UNESCO Agreement on the Importation of Educational, Scientific and Cultural Materials to cover an additional range of educational, scientific, and cultural goods.
