# SCHEDULE EXEMPTIONS FROM SALES TAX

Goods

	Beverages and beverage bases, viz:
18	Tomato concentrate, vegetable juice, fruit juice, concentrated fruit juice, as specified in regulations 173, 174, 183, and 184 of the Food Regulations 1984.
20	Milk or raw milk, pasteurised milk and pasteurised milk products, UHT (ultra heat treated) milk and UHT milk products, standard milk, recombined milk, flavoured milk, skim or non-fat milk, cream or raw cream, whipping cream or whipped cream, light cream, reduced cream, pouring cream and sour cream, cream filling, cake cream, or sponge cream, recombined cream, milk beverages or milk shakes, evaporated milk and evaporated skim milk, sweetened condensed milk and skimmed sweetened condensed milk, milk powder or dried non-fat milk solids, as specified in regulations 92 to 110 of the Food Regulations 1984.
21	Tea, instant tea or soluble tea, coffee, chicory, coffee and chicory, coffee essence or coffee extract, coffee and chicory essence or coffee and chicory extract, instant coffee or soluble coffee, cocoa beans, cocoa nibs or cracked cocoa, cocoa paste, cocoa mass, or cocoa slab, cocoa or cocoa powder, soluble cocoa or beverage cocoa as specified in regulations 153 to 165 of the Food Regulations 1984, including similar beverage bases, not including beverage
