THE SHOP TRADING HOURS (APPROVED GOODS EXTENSION) **NOTICE 1990**

PURSUANT to section 9(1) of the Shop Trading Hours Act 1977, the Minister of Labour hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Shop Trading Hours (Approved Goods Extension) Notice 1990.

(2) Clause 3 of and the Schedule to this notice shall come into force at 1 p.m. on the 25th day of April 1990.

(3) Subject to subclause (2) of this clause, this notice shall come into force with the close of the 24th day of April 1990.

2. Goods declared no longer to be approved goods for purposes of Anzac Day morning—(1) Subject to subclause (2) of this clause, it is hereby declared that all goods belonging to any class specified in the Schedule to the Shop Trading Hours (Approved Goods) Notice 1990 are no longer approved goods for the purposes of the Shop Trading Hours Act 1977.

(2) Nothing in subclause (1) of this clause affects either of the following notices:

(a) The Shop Trading Hours (Approved Goods) Notice 1985:

(b) The Shop Trading Hours (Approved Goods) Notice 1985, Amendment No. 1.

(3) The Shop Trading Hours (Approved Goods) Notice 1990 is hereby revoked.

3. Goods declared to be approved goods after Anzac Day morning-(1) It is hereby declared that all goods belonging to any class specified in the Schedule to this notice are approved goods for the purposes of the Shop Trading Hours Act 1977.

(2) Subject to subclause (1) of this clause, it is hereby declared that all goods belonging to any class specified in-

(a) The Schedule to the Shop Trading Hours (Approved Goods) Notice 1985: or

are no longer approved goods for the purposes of the Shop Trading Hours Act 1977.

Books and Printed Materials

All books and other printed materials.

Clothing

All clothing and fabric.

Drinks

All drinks.

Electrical Appliances

All audio equipment, food processors, microwave ovens, electric ovens, radios, television sets, video recorders, video cassettes, whiteware, and other electrical appliances designed primarily for household use; and all parts and accessories for any such equipment or appliance.

Food

All food (including food for birds, animals, and fish).

Footwear

All footwear and footwear accessories.

Furniture and floor coverings

All furniture and fittings, designed primarily for household use. All furnishings and floor coverings.

Gas Appliances

All lamps, cooking equipment, and other gas appliances designed primarily for household use; and all parts and accessories for any such appliance.

Gardening Supplies

All gardening supplies.

Groceries All groceries.

Haberdashery All haberdashery.

APPROVED GOODS—continued

Handicrafts

All handicraft items (in whatever state of finish).

Hardware Items

All building and plumbing supplies and materials, decorative products, hand held tools, garden hardware, lawn mowers, and other hardware supplies.

Household Goods

All kitchenware, cookware, tableware, utensils, clocks, ornaments, decorations, works of art, lighting equipment, baby equipment, wrapping paper, ribbons, bows, writing equipment, and stationery; and all parts and accessories for any such goods.

All goods used for household or personal cleaning.

Luggage

All luggage.

Manchester

All manchester and linen.

Meats and Poultry

All meats and poultry.

Medicines

All medicines and medicated preparations.

Musical Equipment

All musical instruments, parts, and accessories. All sheet music. All records, cassette tapes, and compact discs.

Personal Items

All watches, calculators, cosmetics, jewellery, tobacco products, toiletries, shaving equipment, and other small personal items designed to be worn or carried or used about the person.

Pets and Pet Supplies

Cats, dogs, rabbits, hamsters, guinea pigs, mice, rats, birds, and other animals commonly sold as pets, and all cages and pet supplies.

Photographic Goods

All photographs, picture frames, and photographic equipment; and all parts and accessories for any such equipment.

Plants

Plants of any kind in any state (including corms, plants, seedlings, seeds, shrubs, trees, and tubers).

Safety Equipment

All personal safety equipment.

Souvenirs

All items sold as souvenirs.

Sporting, Recreational, and Leisure Equipment

- All sporting, recreational, or leisure equipment, items, or materials (excluding computer hardware, vessels powered or designed to be powered by fuel or electricity, vehicles powered by fuel or electricity, caravans, trailers, and horsefloats); and all parts and accessories for any such equipment, items, or materials.
- Parts and accessories for vessels powered or designed to be powered by fuel or electricity.

Stamps, Coins, and Memorabilia

All stamps, coins, and memorabilia.

Toys

All toys and games.

Veterinary Products

All animal remedies and animal medicines.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice does 2 things. First, as from midnight on 24 April 1990 (that is to say the beginning of Anzac Day 1990), it revokes the Shop Trading Hours (Approved Goods) Notice 1990 (due to expire on 30 April 1990) which declared an extended list of goods to be approved goods for the purposes of the Shop Trading Hours Act 1977. Secondly, as from 1 p.m. on Anzac day 1990 it reinstates that list for an indefinite period.

The effect is that on Anzac day morning, only the limited classes of goods declared to be approved goods by the Shop Trading Hours (Approved Goods) Notice 1985 or the Shop Trading Hours (Approved Goods) Notice 1985, Amendment No. 1, will be approved goods.
