## THE TE AROHA MILK DISTRICT ORDER 1958

### ORDER IN COUNCIL

At the Government House at Wellington this 17th day of September 1958

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Milk Act 1944, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

### ORDER

1. (1) This order may be cited as the Te Aroha Milk District Order 1958.

(2) This order shall come into force on the day after the date of its notification in the *Gazette*.

2. The Te Aroha Milk District, as constituted by the Te Aroha Milk District Constitution Order 1948,\* shall hereafter consist of the Borough of Te Aroha and parts of the Piako and Ohinemuri Counties; and the boundaries of the said district shall be those specified in the Schedule hereto.

3. The Milk Authority for the said district shall continue to be the Te Aroha Borough Council.

4. The Piako County Council and the Ohinemuri County Council shall each be entitled to have a representative on the Milk Committee of the Te Aroha Borough Council and from time to time to nominate one person for that purpose.

5. The Te Aroha Borough Council shall from time to time appoint to the Milk Committee of the Borough Council the persons nominated by the Piako County Council and the Ohinemuri County Council pursuant to clause 4 hereof.

6. The Te Aroha Milk District Constitution Order 1948\* is hereby revoked.

## SCHEDULE

ALL that area in the South Auckland Land District, containing 8,800 acres approximately, being the Borough of Te Aroha and part of the Counties of Piako and Ohinemuri, bounded by a line commencing at a point in the middle of the Waihou River in line with the northern boundary of Lot 5, D.P. 36599, being part Section 5B, Block V, Aroha Survey District, and proceeding easterly along a right line to and along the said northern boundary and along a right line crossing the East Coast Main Trunk Railway, Lot 1, D.P. 36599, and Hamilton-Paeroa State Highway to and along the northern boundary of another part of the said Section 5B to a point 5 chains distant from and at right angles to the eastern side of the aforesaid highway; thence southerly along a right line parallel to and 5 chains distant from the eastern side of that highway to the northern boundary of Lot 1, D.P.S. 5204, being part Lot 2A 3, Section 28, Block IX, Aroha Survey District; thence easterly along the northern and eastern boundaries of that lot, the southern boundaries of another part of Lot 2A 3, Section 28, and the western and southern boundaries of Section 121, Block IX, Aroha Survey District, to a point in line with the eastern boundary of the Borough of Te Aroha; thence again southerly along a right line to and along the eastern boundary of the said borough as described in *New Zealand Gazette*, 1917, page 1868, to the middle of the Haehanga Stream; thence westerly generally down the middle of that stream to and up the middle of the Waihou River to a point in line with the middle of McCabes Road; thence along a right line to and along the middle of that road to a point in line with the eastern boundary of the land shown on D.P. 10911, being part Section N.W. 9, Block XI, Aroha Survey District; thence along a right line to and along the eastern and southern boundaries of that section, the southern boundary of another part of Section N.W. 9, Block XI aforesaid, and its production to the middle of Mikkelsen's Road; thence along the middle of that road to a point in line with the north-western boundary of Lot 1, D.P. 113, being part Te Kapara Block; thence westerly generally along a right line to and along the north-western boundary of the said Lot 1, the north-western boundary of Lot 5, D.P. 113 aforesaid, and its production across a public road and Lot 1, D.P. 12701, being another part Te Kapara Block to and down the middle of the Waiwhero Stream to a point in line with the south-eastern boundary of part Lot 1, D.P. 15461, being part Waihekau 3 Block; thence again westerly along a right line to and along the south-eastern and south-western boundaries of the said part Lot 1, D.P. 15461, the northern boundaries of Lots 7 and 2, D.P. 15461 aforesaid, and the production of the last-mentioned boundary to the middle of the Piraunui Stream; thence up the middle of that stream to a point in line with the northern boundary of Section 38, Block XVI, Waitoa Survey District; thence along a right line to and along that northern boundary and its production to the middle of a public road; thence along the middle of that road to a point in line with the north-western boundary of Lot 5, D.P. 12887, being part Waihekau 1 Block; thence along a right line to and along the north-western and western boundaries of that lot, the northern boundary of Lot 3, D.P. 12925 aforesaid, and its production across the Waitoa-Matamata Main Highway, Section 11, Block IV, Maungakawa Survey District, and a public road to the middle of the Waitoa River; thence

southerly up the middle of that river to a point in line with the northern boundary of part Lot 1, D.P. 8914; thence along a right line to and along that boundary, along a right line across and along the northern side of Farmers Road to and along the northern boundary of Lot 5, D.P. 9502, being part Te Kahia Block, to the south-eastern corner of Lot 1, D.P. 27698, being part Waokauri 1 Block in Block IV, Maungakawa Survey District; thence northerly generally along the eastern boundary of the aforesaid Lot 1 and its production across the Te Aroha - Morrinsville Main Highway and the East Coast Main Trunk Railway to and along the northern side of that railway, the south-western and north-western boundaries of part Lot 58, D.P. 4444, being part Waokauri 1 Block, a right line diagonally across No. 1 Road to and along the south-eastern boundary of Lot 3, D.P. 4444 aforesaid, and its production to the middle of the Waitoa River; thence down the middle of that river to and up the middle of the Waihekau Stream to and along the northern side of the East Coast Main Trunk Railway, down the middle of the Piraunui Stream to a point in line with the south-eastern boundary of part Ngutumanga Block as shown on D.P. 10819; thence along a right line to and along the south-eastern and eastern boundaries of that block to a point in line with the southern boundary of Lot 2, D.P. 23932, being part Sections 5 and 17, Block XVI, Waitoa Survey District; thence along a right line across Ngutumanga Road to and along that southern boundary, the southern boundary of Lot 3, D.P. 23932 aforesaid, and its production to the middle of Goulds Road; thence northerly along the middle of that road and the middle of Te Kawana Road to and along the boundary of the Borough of Te Aroha aforementioned to and down the middle of the Waihou River to the point of commencement; as the same is more particularly delineated on plan No. NZMB 89/1 deposited in the Hamilton District Office of the New Zealand Milk Board.

## EXPLANATORY NOTE

*This note is not part of the order, but is intended to indicate its general effect.*

This order redefines the Te Aroha Milk District, for which the Te Aroha Borough Council is the Milk Authority, so as to include portions of the Piako and Ohinemuri Counties not at present within the milk district. The order also entitles each of the counties to have a representative on the Milk Committee of the Te Aroha Borough Council.
