ORDER IN COUNCIL

THE HON. D. C. MCKINNON PRESIDING IN COUNCIL

PURSUANT to sections 9 and 10 of the Tariff Act 1988, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and being satisfied that the rates of duty specified in Tariff items 6401.10.08 and 6401.92.09 of the Tariff are necessary or advisable in the public interest and are in conformity with New Zealand's international obligations, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Tariff (Gumboots) Amendment Order 1991.

(2) This order shall come into force on the 1st day of July 1991.

2. Tariff amended—The Tariff is hereby amended by revoking so much of Part I as relates to Tariff items 6401.10.01 and 6401.92.01, and substituting the Tariff items, rates of duty, and statistical keys specified in the Schedule to this order.

3. Consequential revocation—The Tariff (Miscellaneous) Amendment Order (No. 2) 1989 (S.R. 1989/147) is hereby amended by revoking so much of the Schedule to that order as relates to Tariff item 6401.92.01.
