HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to sections 9 and 10 of the Tariff Act 1988, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

**1. Title and commencement**—(1) This order may be cited as the Tariff (Miscellaneous) Amendment Order (No. 2) 1994.

(2) This order shall come into force on the 1st day of July 1994.

**2. Note to Tariff amended**—The Tariff is hereby amended—

(a) By inserting in the heading to Note 1 (which appears at the beginning of the Tariff), after the words “General Rules for the Interpretation of”, the words “Part I of”:

(b) By inserting in the sentence first following that heading, after the words “Classification of goods in”, the words “Part I of”.

**3. Tariff amended**—The Tariff is hereby amended by revoking so much of Part I as relates to Tariff items 6309.00.01, 6309.00.11, 6309.00.19, 9506.11.00, and 9506.12.00, and substituting the items, rates of duty, and statistical keys specified in the Schedule to this order.

**4. Consequential revocations**—(1) The Tariff (Worn Clothing and Footwear) Amendment Order 1991 (S.R. 1991/290) is hereby revoked.

(2) The Tariff (Miscellaneous) Amendment Order 1993 (S.R. 1993/139) is hereby amended by revoking so much of the Schedule as relates to Tariff items 9506.11.00, and 9506.12.00.

## EXPLANATORY NOTE

*This note is not part of the order, but is intended to indicate its general effect.*

This order, which comes into force on 1 July 1994, makes the following changes to the Tariff:

- (a) Snow skis of Tariff item 9506.11.00 and ski fastenings (bindings) of Tariff item 9506.12.00 become duty-free;
- (b) Tariffs on worn clothing of Tariff item 6309.00.01 and worn footwear of Tariff item 6309.00.11 reduce to \$6.56 per kilogram on 1 July 1994 and to \$5.63 per kilogram on 1 July 1996;
- (c) Note 1 to the Tariff is altered to make it clear that the general rules for the interpretation of the Tariff apply to the classification of goods in Part I of the Tariff only, and not Part II.
