HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Tertiary Bursaries Regulations 1976, Amendment No. 1, and shall be read together with and deemed part of the Tertiary Bursaries Regulations 1976* (hereinafter referred to as the principal regulations).

(2) Regulations 1, 3, 8, 9, and 11 of these regulations shall come into force on the day after the date of the notification of these regulations in the *Gazette*.

(3) Subject to subclause (2) of this regulation, these regulations shall come into force on the 1st day of February 1978.

2. Exercise of Director-General's powers by Councils of tertiary institutions, etc.—Regulation 4 (6) of the principal regulations is hereby amended—

- (a) By inserting, after the expression “17 (2)”, the expression “17 (5)”:
- (b) By inserting, after the expression “32 (5)”, the expression “32 (7)”.

3. Restrictions on employment—(1) The principal regulations are hereby further amended by revoking regulation 8.

(2) Regulation 23 (1) of the principal regulations is hereby consequentially amended by omitting the expression “regulations 8 and 10”, and substituting the expression “regulation 10”.

4. Value of tertiary bursary—(1) Regulation 12 (1) (a) of the principal regulations is hereby amended by omitting the expression “\$24”, and substituting the expression “\$26”.

(2) Regulation 12 (1) (b) of the principal regulations is hereby amended by omitting the expression “\$27”, and substituting the expression “\$29”.

(3) The said regulation 12 is hereby further amended by revoking subclause (2), and substituting the following subclause:

“(2) A bursary shall be payable in any year in respect of a recognised course of study for a period commencing with the beginning of the week when in the opinion of the Director-General, the course commences, and ending at the end of the week during which, in the opinion of the Director-General, the course ends:

Provided that where examinations in respect of that course commence within 6 weeks of the end of that period, the bursary shall continue to be paid until the end of the week in which the last such examination is held.”

5. Abatement of tertiary bursary—Regulation 13 (1) of the principal regulations is hereby amended by omitting the expressions “\$13” and “\$16”, and substituting, respectively, the expressions “\$15” and “\$18”.

6. Married students—Regulation 14 (3) of the principal regulations is hereby amended by omitting the expression “\$48”, and substituting the expression “\$50”.

7. Extension of usual term of tertiary bursary—(1) Regulation 17 of the principal regulations is hereby amended by revoking subclause (3), and substituting the following subclause:

“(3) If a bursar has completed one recognised course of study and has enrolled for a second recognised course of study, the Director-General may extend the payment of the tertiary bursary for such a period as is, in his opinion, the minimum period required for the completion of the second course:

Provided that in the case of a bursar enrolled at a university, the Director-General may, on the recommendation of the Professorial Board,

extend the payment of the tertiary bursary in respect of the second course during the final year of the recognised course of study first undertaken by the bursar.

(2) The said regulation 17 is hereby further amended by revoking subclauses (7), (8), (11), (12), and (13).

8. Reinstatement of tertiary bursary—Regulation 21 of the principal regulations is hereby amended—

- (a) By omitting the words “, in a subsequent year of study”, and substituting the word “subsequently”; and
- (b) By revoking the proviso.

9. Academic qualifications for tertiary bursary—(1) Regulation 30 (a) of the principal regulations is hereby amended by revoking subparagraph (iv), and substituting the following subparagraph:

“(iv) Enrolled for the first time in a recognised course at a tertiary institution after a period of 2 years or more since qualifying academically for entrance to a university as aforesaid; or”.

(2) The said regulation 30 (a) is hereby amended by adding the following subparagraph:

“(vi) Enrolled for the first time in a recognised course at a tertiary institution after a period of 3 years or more since leaving school during which period he has qualified for entrance to a university:

“Provided that, for the purposes of this subparagraph, attendance at a secondary school pursuant to section 93 (5) of the Education Act 1964 shall be deemed to take place after the person so attending has left school.”

(3) Regulation 30 (b) of the principal regulations is hereby amended by omitting the words “in any year, whether before or after the commencement of these regulations, but before the year in which the bursary is awarded”, and substituting the words “, whether before or after the commencement of these regulations,”.

(4) Regulation 30 (c) of the principal regulations is hereby amended by omitting the words “but before the year in which the bursary is awarded”.

10. Tertiary bursary awarded or extended for masters study—(1) Regulation 32 (1) of the principal regulations is hereby amended by revoking paragraph (b).

(2) Regulation 32 (2) of the principal regulations is hereby amended by omitting the words “or from proceeding within the prescribed time to the course of study leading to a masters degree”.

(3) The said regulation 32 is hereby further amended by adding the following subclause:

“(7) Notwithstanding regulation 7 of these regulations, if the Director-General is satisfied that work required to be carried out by a bursar as part of a course of study leading to a masters degree cannot

adequately be carried out in New Zealand, he may approve the payment of a tertiary bursary to that bursar for a period not exceeding one year while the bursar carries out that work outside New Zealand.”

11. Payment of additional tuition fees—Regulation 35 (1) of the principal regulations is hereby amended by omitting the words “of study”.

12. Extension of benefits of fees bursary—Regulation 37 (2) of the principal regulations is hereby amended by revoking paragraph (a).

13. Award of tertiary bursary to teachers college students—The principal regulations are hereby further amended by revoking regulation 41, and substituting the following regulation:

“41. The Director-General may award a tertiary bursary to a full-time student who is enrolled at a teachers college in a recognised course of study (other than a one year woodwork, metalwork, engineering, commercial, Maori language, or music course) that he commenced in or after 1976 and who is not enrolled in a Division C course, a Division AG course, or a Division B course that has been reduced to one year.”

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations give effect to various changes in the award of the standard tertiary bursary announced in the Budget.
