## THE TEACHER BURSARIES REGULATIONS 1986

#### ORDER IN COUNCIL

# Present:

#### HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Teacher Bursaries Regulations 1986.
- (2) These regulations shall come into force on the 1st day of February 1986.
- **2.** Interpretation—In these regulations, unless the context otherwise requires,—
  - "The Act" means the Education Act 1964:
  - "Approved course" means any papers at a university—
    - (a) Together constituting a course in respect of which there may be awarded a degree or diploma; and
    - (b) For the time being approved by the Director-General for the purposes of these regulations:

- "Bursary" means a teacher bursary established by regulation 3 of these regulations:
- "Teacher" means a person who is permanently appointed to a fulltime teaching position at a school established under Part III of the Act:
- "University" has the same meaning as in section 2 of the Universities Act 1961.
- **3. Teacher bursaries established**—There are hereby established bursaries to be known as teacher bursaries.
- **4. Applications**—Any teacher who in any year is enrolled or proposes to enrol in any course at a university may apply to the Director-General, on a form provided by the Director-General for the purpose, for a bursary for that year in respect of that course.
- **5 Award of bursaries**—(1) Subject to subclauses (2) and (3) of this regulation, the Director-General shall award a bursary to an applicant for a bursary for any year in respect of any course if, and only if,—
  - (a) That applicant has already completed a degree or diploma at a university; and
  - (b) That course is an approved course.
- (2) Except in circumstances that are, in the opinion of the Director-General, exceptional, no bursary shall be awarded to any teacher for any year if that teacher's application for it was not received by the Director-General before the 15th day of February in that year.
- (3) Subject to subclause (4) of this regulation, no bursary shall be awarded to any applicant who,—
  - (a) In any year, while the holder of a bursary, failed all or any part of the course in respect of which it was awarded; and
  - (b) Has not thereafter passed the work failed.
- (4) The Director-General may, if satisfied that any failure by the holder of a bursary was due to reasons beyond that holder's control, direct that that failure should be disregarded for the purposes of subclause (3) of this regulation; and in that case that failure shall be disregarded accordingly.
- **6. Holders of bursaries to receive tuition fees**—The holder of a bursary in any year shall be paid under that bursary during that year the full tuition fees of that portion of the approved course in respect of which that bursary was awarded in which that holder is enrolled in that year.

## EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations provide for the award of bursaries to teachers who already have a university degree or diploma and who are undertaking university study towards some other degree or diploma approved by the Director-General. The bursary covers the tuition fees for the further study.
