Pursuant to sections 9 and 10 of the Tariff Act 1988, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and being satisfied that the rates of duty specified in Tariff items 6309.00.01 and 6309.00.11 of the Tariff are necessary or advisable in the public interest and are in conformity with New Zealand's international obligations, hereby makes the following order.

### ORDER

1. Title and commencement—(1) This order may be cited as the Tariff (Worn Clothing and Footwear) Amendment Order 1991.

(2) This order shall come into force on the 1st day of February 1992.

2. Tariff amended—The Tariff is hereby amended by revoking so much of Part I as relates to item 6309.00.00, and substituting the Tariff items, rates of duty, and statistical keys specified in the Schedule to this order.

# Tariff (Worn Clothing and Footwear) Amendment Order 1991

## EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into effect on 1 February 1992, imposes duty on wearable secondhand clothing and footwear in order to accord such goods Tariff treatment similar to that for imported new clothing and footwear.
