**THE TRANSPORT (GOODS) CONTROLLED AREAS ORDER 1942**

ORDER IN COUNCIL.

At the Government House at Wellington, this 4th day of
February, 1942.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Transport Licensing Act, 1931 (hereinafter called the said Act), His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby order as follows :—

1. This Order may be cited as the Transport (Goods) Controlled Areas Order 1942.

2. This Order shall come into force on the day following notification hereof in the *Gazette*.*

3. The Orders in Council referred to in the First Schedule hereto are revoked.

4. All registers, appointments, licenses, applications, notices, and generally all acts of authority and all other documents, matters, acts, and things, and all periods of time, which originated or had effect under the Orders in Council hereby revoked and are of continuing effect at the time of coming into force of this Order shall enure for the purposes of this Order, or, as the case may be, for the purposes of the Transport (Goods) Applied Provisions Order 1942† as if they had originated under this Order or the Transport (Goods) Applied Provisions Order 1942, and shall, where necessary, be deemed to have so originated.

5. On and from the date of coming into force of this Order the transport districts as constituted by the said Act and the Transport (Passenger) Order 1936‡, the names of which are set out in the First Column of the Second Schedule hereto, shall respectively be the controlled areas the names of which are set out in the Second Column of the said Schedule.

6. The Licensing Authorities named in the Third Column of the said Second Schedule hereto shall be the Licensing Authorities of the said respective controlled areas.
