**THE TRADES CERTIFICATION BOARD (FEES AND
TRAVELLING-ALLOWANCE) REGULATIONS 1950**

ORDER IN COUNCIL

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Trades Certification Act, 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Trades Certification Board (Fees and Travelling-allowance) Regulations 1950.

FEES AND ALLOWANCES

2. (1) There shall be paid to the Chairman of the New Zealand Trades Certification Board an allowance in respect of his services at the rate of £500 a year or at such lesser rate as the Minister of Finance may from time to time determine.

(2) There shall be paid to every other member of the Board, or of any committee of the Board, who is not an officer or employee in the Government service within the meaning of the Superannuation Act, 1947, an allowance of £2 2s. for each day or part of a day during which he is attending a meeting of the Board or of any of its committees, or is travelling to or from any such meeting, or is travelling or occupied in connection with the business of the Board with the prior approval of the Board or of the Chairman.

(3) There shall be paid to every person co-opted to advise the Board, who is not an officer or employee in the said Government service, for each such day or part of a day, an allowance of £2 2s. or of such lesser amount as may be determined by the Board after taking into account the actual time involved.

TRAVELLING-ALLOWANCES

3. (1) The Travelling-allowance Regulations 1949* shall apply to and be deemed to be incorporated in these regulations so as to relate to—

- (a) The New Zealand Trades Certification Board and its members ;
and
- (b) The members of any committee appointed by the Board and any persons co-opted to advise the Board as if they were members of the Board.

(2) The subsistence allowance referred to in Regulation 5 of the Travelling-allowance Regulations 1949* shall be at the rate of £1 15s. a day :

Provided that where a member is entitled to a subsistence allowance and occupies a hotel room for one night only, an additional amount of 2s. may be paid to that member.

(3) The mileage allowance referred to in regulation 13 of the Travelling-allowance Regulations 1949 shall be calculated in accordance with the following table :—

Horse-power of Car.	Mileage Allowance.
Not exceeding 9½	5½d. a mile.
Exceeding 9½ but not exceeding 14½	6¼d. a mile.
Over 14½	7d. a mile.

(4) Garage expenses payable to a member pursuant to regulation 13 of the Travelling-allowance Regulations 1949 shall not exceed 2s. 6d. for every night on which any such expenses are incurred.
