THE TRAINING COLLEGE REGULATIONS 1926, AMENDMENT NO. 18.

GALWAY, Governor-General.

ORDER IN COUNCIL.

At the Government House at Wellington, this 14th day of September, 1938.

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

Pursuant to the Education Act, 1914, His Excellency the Governor-General, acting by and with the advice of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

- 1. These regulations may be cited as the Training College Regulations 1926, Amendment No. 18.
- 2. These regulations shall be read together with and form part of the regulations made by Order in Council dated the 13th day of December, 1926* (hereinafter referred to as the principal regulations), as amended from time to time.
- 3. These regulations shall come into force on the day following notification in the Gazette of the making hereof.†
- **4.** Clause 9 of the principal regulations (as substituted by the Training College Regulations 1926, Amendment No. 14,‡ hereinafter referred to as Amendment No. 14) is amended by:
 - (1) Omitting from paragraphs (a) and (b) of subclause (2) thereof the word 'November", and substituting the word "October":
 - (2) Omitting subclause (3) thereof, and substituting the following— "(3) Applicants for admission as students of Division C. and also those applicants for admission in Division A, who do not possess the qualification prescribed in clause 11 (1) hereof, but who are candidates for the Training College Entrance Examination 1938, may submit their applications in anticipation of their obtaining the necessary qualifications by the time the training colleges open."

- 5. Clause 11 of the principal regulations (as substituted by Amendment No. 14) is amended by omitting subclause (1) thereof, and substituting the following:—
- "(1) To be admitted in Division A an applicant must, prior to his application for admission, have obtained a pass in either the University Entrance or the School Certificate Examination, or have obtained some other qualification approved by the Director."
- 6. Clause 14 of the principal regulations (as substituted by Amendment No. 14) is amended by omitting paragraph (a) of subclause (1) thereof, and substituting the following:—
 - "(a) Be the holder of a New Zealand Teacher's Certificate not lower than Class D, or a New Zealand Handicraft Teacher's Certificate."
- 7. Clause 22 of the principal regulations (as made on the 29th October, 1929)* is amended by omitting subclause (3) thereof.
