



**THE TROUT-FISHING (NORTH CANTERBURY) REGULATIONS
1937, NO. 2, AMENDMENT NO. 6**

ORDER IN COUNCIL

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Fisheries Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Trout-fishing (North Canterbury) Regulations 1937, No. 2, Amendment No. 6.

2. These regulations shall be read together with and form part of the Trout-fishing (North Canterbury) Regulations 1937, No. 2* (hereinafter referred to as the principal regulations).

3. These regulations shall come into force on the 1st day of October, 1944.

4. Paragraph (e) of Regulation 5 of the principal regulations, as substituted by Regulation 4 of the Trout-fishing (North Canterbury) Regulations 1937, No. 2, Amendment No. 3, and as amended by paragraph (b) of Regulation 4 of the Trout-fishing (North Canterbury) Regulations 1937, No. 2, Amendment No. 4, is revoked, and the following paragraph substituted therefor:—

“(e) For salmon in rivers and streams only from the 16th day of October to the 15th day of May in the year following, both days inclusive :

“ Provided that no person shall fish for salmon in the Rakaia River above the Gorge Bridge after the 31st day of March until the 16th day of October next following.”

5. Regulation 12 of the principal regulations, as substituted by Regulation 7 of the Trout-fishing (North Canterbury) Regulations 1937, No. 2, Amendment No. 1, and the said Regulation 7, are revoked.
