THE TRANSPORT CHARGES REGULATIONS 1948

ORDER IN COUNCIL

At the Government House at Wellington, this 22nd day of December, 1948

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Transport Licensing Act, 1931, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Transport Charges Regulations 1948.

2. In these regulations—

- "Transport Charges Committee " means the Transport Charges Committee established under the Transport Law Amendment Act, 1948:
- "Transport Charges Appeal Authority" means the Transport Charges Appeal Authority appointed under the Transport Law Amendment Act, 1948.

Application to Transport Charges Committee

3. Every application to fix, review, or alter charges forwarded to the Commissioner of Transport for transmission to the Transport Charges Committee shall be in form T.L. 120 in the Schedule hereto, and shall be accompanied by the prescribed fee.

TRANSPORT CHARGES APPEALS

4. (1) Every appeal against an order of the Transport Charges Committee forwarded to the Commissioner of Transport for reference to the Transport Charges Appeal Authority shall be in form T.L. 121 in the Schedule hereto.

(2) No appeal shall be deemed to have been duly lodged unless it is accompanied by the prescribed fee.

(3) A copy of any correspondence or other documents relating to the subject-matter of the appeal and in the possession of the appellant shall be attached to the form of appeal.

(4) Notification of receipt of the appeal shall be forwarded by the Commissioner to the Transport Charges Committee, and the Transport Charges Committee shall thereupon cause to be forwarded to the Transport Charges Appeal Authority, through the Commissioner of Transport, a copy of any notes of evidence taken by the Committee concerning the subject-matter of the appeal.

(5) The Commissioner of Transport shall forward the papers relative to the appeal to the Transport Charges Appeal Authority.
