ORDER IN COUNCIL

At the Government House at Wellington this 25th day of June 1973

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Food and Drug Act 1969, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Therapeutic Drugs (Permitted Sales) Regulations 1972, Amendment No. 2, and shall be read together with and deemed part of the Therapeutic Drugs (Permitted Sales) Regulations 1972* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. Therapeutic drugs that may be sold freely—(1) Part I of the Schedule to the principal regulations is hereby amended by omitting from the item relating to herbs the word “uncompounded”.

(2) Part II of the Schedule to the principal regulations (as amended by regulation 2 of the Therapeutic Drugs (Permitted Sales) Regulations 1972, Amendment No. 1) is hereby further amended by inserting, in their appropriate alphabetical order, the following items:

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations add 28 new items to the list of therapeutic drugs that may be sold freely in New Zealand (subject to sections 12, 14, and 18 (1) of the Food and Drug Act 1969).

In addition, the item relating to herbs is widened to apply to all herbs in dry form, whether or not compounded, that are packed under the traditional or botanical name.
