



**THE THERAPEUTIC DRUGS (PERMITTED SALES)
REGULATIONS 1978, AMENDMENT NO. 5**

ORDER IN COUNCIL

At the Government House at Wellington this 18th day of May 1981

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 46 (1) (v) of the Food and Drug Act 1969, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Therapeutic Drugs (Permitted Sales) Regulations 1978, Amendment No. 5, and shall be read together with and deemed part of the Therapeutic Drugs (Permitted Sales) Regulations 1978* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 14th day after the date of their notification in the *Gazette*.

2. Therapeutic drugs that may be sold freely—Part II of the Schedule to the principal regulations (as amended from time to time) is hereby further amended by inserting, in their appropriate alphabetical order, the following items:

- “Andrews Health Salt (Flavoured)
- “Aspro Clear
- “Le Page’s Elder Flowers, Peppermint with Composition Essence
- “Le Page’s Hair Rejuvenator
- “Le Page’s Inhalant
- “Le Page’s Rheumatic Medicine

3. Further amendments to Schedule to principal regulations—

Part II of the Schedule to the principal regulations (as amended by regulation 2 of the Therapeutic Drugs (Permitted Sales) Regulations 1978, Amendment No. 3) is hereby further amended by omitting the following items:

- “Red Seal Rheumatism Tablets
- “Red Seal Sennalax Tablets.”

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations are made pursuant to the Food and Drug Act 1969, and amend the Therapeutic Drugs (Permitted Sales) Regulations 1978.

They add the substances specified in regulation 2 to the list of therapeutic drugs that may be sold freely under the principal regulations, and remove from that list the substances specified in regulation 3.

Date of notification in *Gazette*: 21 May 1981.
