**THE TRANSPORT (FEES FOR DETAILS OF REGISTER)  
REGULATIONS 1987**

ORDER IN COUNCIL

At Wellington this 13th day of July 1987

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to sections 19 and 48 of the Transport (Vehicle and Driver Registration and Licensing) Act 1986, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Transport (Fees for Details of Register) Regulations 1987.

(2) These regulations shall come into force on the 1st day of August 1987.

**2. Fees**—(1) The fee for supplying a certificate under section 19 (1) of the Transport (Vehicle and Driver Registration and Licensing) Act 1986 of the particulars of all persons who are or have been registered owners of a specified motor vehicle is \$10.00.

(2) Except as provided in subclauses (3) to (5) of this regulation, the fee for a certificate under section 19 (2) of that Act of the name and address of the current registered owner of a specified motor vehicle is \$2.00.

(3) Where the information that would be contained in a certificate given under section 19 (2) of that Act is given by telephone, the fee is 75 cents.

(4) Where the information that would be contained in a certificate given under section 19 (2) of that Act is given in the form of a list relating to 2 or more vehicles and is given for the purposes of the enforcement of any Act to any constable, traffic officer, parking warden, or other person employed by the Crown or a local authority, the fee is 50 cents in respect of each vehicle.

(5) Where the information that would be contained in a certificate given under section 19 (2) of that Act is sought and given by means of magnetic tape, and is given for the purposes of the enforcement of any Act to any constable, traffic officer, parking warden, or other person employed by the Crown or a local authority, the fee is \$6.00 per tape plus 2 cents in respect of each vehicle.

**3. Amount of goods and services tax excluded**—It is hereby declared that the fees fixed by these regulations are exclusive of any goods and services tax payable under the Goods and Services Tax Act 1985.

**4. Revocation**—The Transport (Fees for Details of Motor Vehicle Register) Regulations 1981\* are hereby revoked.

#### EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 1 August 1987, set the following fees:

- Fee for certificate of particulars of past and current registered owners of a motor vehicle, \$10.00:
- Fee for certificate of name and address of current registered owner of motor vehicle, \$2.00:
- Fee for information as to current registered owner of motor vehicle given by telephone, 75 cents:
- Fee for information given in bulk to the police, traffic officers, parking wardens, and officers of the Crown or local authorities for enforcement purposes, 50 cents per vehicle (if supplied in list form) or \$6 per tape and 2 cents per vehicle (if sought and supplied in magnetic tape form).

By virtue of section 19 of the Act, the fee for the first certificate must accompany the application. In other cases the Registrar may decline to give the certificate or information unless the fee is paid or adequate arrangements have been made for later payment.
