HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 14 of the Maori Land Amendment and Maori Land Claims Adjustment Act 1926, and to sections 48 and 48A of the Conservation Act 1987, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title, commencement, and application—(1) These regulations may be cited as the Taupo Fishing Regulations 1984, Amendment No. 6, and shall be read together with and deemed part of the Taupo Fishing Regulations 1984* (hereinafter referred to as the principal regulations).
 - (2) These regulations shall come into force on the 1st day of July 1991.
- (3) These regulations shall apply in respect of all licences issued in respect of any period commencing on or after the 1st day of July 1991.
- **2. Interpretation**—Regulation 2 (1) of the principal regulations is hereby amended by inserting, in their appropriate alphabetical order, the following definitions:

"'Committee' means the Taupo Fishery Advisory Committee

established under regulation 38A of these regulations:

"'Department' means the Department of Conservation: "'Minister' means the Minister of Conservation:".

- **3. Rights to fish conferred by licences**—Regulation 10 of the principal regulations is hereby amended by revoking subclause (2).
- **4. Bag and size limit**—Regulation 20 (1) of the principal regulations is hereby amended by omitting the expression "8" in both places where it occurs, and substituting in each case the expression "3".
- **5. New Part substituted**—The principal regulations are hereby amended by inserting, after Part VI, the following Part:

"PART VIA

"TAUPO FISHERY ADVISORY COMMITTEE

"38A. Taupo Fishery Advisory Committee established—(1) The Minister shall establish for the Taupo Fishery an advisory user group to be known as the Taupo Fishery Advisory Committee.

"(2) The Taupo Fishery Advisory Committee shall consist of the

following members:

"(a) Six members appointed by the Minister from persons nominated by the organisations specified in the Fifth Schedule to these regulations:

"(b) One member who shall represent the Tuwharetoa Maori Trust Board and be appointed by the Minister on advice from the

Board:

"(c) One member appointed by the Minister to represent national

angling interests:

"(d) One member who shall represent the New Zealand Fish and Game Council and be appointed by the Minister on advice from the Council:

"(e) One member appointed by the Minister to represent the

appropriate Regional Conservator of the Department.

"(3) The members appointed under paragraphs (a), (b), and (c) of subclause (2) of this regulation shall have voting rights at meetings of the Committee, and the other members of the Committee shall be entitled to

- "38B. Functions of Committee—The functions of the Committee shall be—
 - "(a) To advocate Taupo sport fishing interests:
 - "(b) To facilitate communication between the Department and anglers to keep anglers informed on matters affecting their interests:
 - "(c) To foster ethical standards of angling behaviour:
 - "(d) To consider and advise the Department on freshwater and sport fishing matters within the Taupo district:
 - "(e) To make such representations as it sees fit to the Minister, or to the Department or any other Government agency or other organisation, on matters affecting the Taupo Fishery, including national and regional policy statements, management strategies, and management plans:
 - "(f) To liaise with the New Zealand Fish and Game Council on matters of mutual interest relating to sports fish.
- "38c. Members to hold office at pleasure—Members of the Committee shall hold office at the pleasure of the Minister.
- "38D. Chairperson of Committee—(1) The members of the Committee shall elect one of their number to be Chairperson of the Committee for such term as the members think fit.
- "(2) The Chairperson shall preside at all meetings of the Committee at which he or she is present.
- "(3) If the Chairperson is absent from any meeting of the Committee, the members present shall appoint one of their number to be the Chairperson of that meeting.
- "38E. Meetings—(1) Meetings of the Committee shall be held at least 3 times a year at such times and places as the Committee or the Chairperson appoints and the first meeting in each financial year shall be called the annual general meeting of the Committee.
- "(2) The Chairperson may at any time call a special meeting of the Committee, and shall call a special meeting whenever so requested in writing by any 3 or more voting members.
- "(8) At any meeting of the Committee, 4 of the voting members shall constitute a quorum and no business shall be transacted at any meeting unless such a quorum is present.
- "(4) Every question before the Committee shall be decided by a majority of the voting members present and proper minutes shall be kept of proceedings.
- "(5) At any meeting of the Committee, the Chairperson shall have a deliberative vote, and, in the case of an equality of votes, shall also have a casting vote.
- "(6) Subject to these regulations, the Committee may regulate its procedure in such manner as it thinks fit.
- "38F. Other persons who may attend meetings—(1) The Committee may allow persons who are not members of the Committee to attend meetings of the Committee.
- "(2) The Conservator of the Tongariro-Taupo Conservancy of the Department shall be entitled to attend and speak at any meeting of the Committee, but shall not be entitled to vote on any question.

- "(3) Not more than 4 persons representing the Tuwharetoa Maori Trust Board shall be entitled to attend and speak at meetings of the Committee to provide support for the member representing the Board, but those persons shall not be entitled to vote on any question.
- "38_G. Servicing of Committee—The Department shall provide secretarial services to the Committee.
- "38H. Travelling allowances and expenses—(1) The Director-General shall reimburse—
 - "(a) The actual and reasonable travelling and accommodation expenses incurred by voting members of the Committee in respect of their service as members of the Committee:
 - "(b) Half of the actual and reasonable travelling and accommodation expenses incurred by the member representing the New Zealand Fish and Game Council in respect of his or her service as a member of the Committee.
- "(2) Except as provided in subclause (1) of this regulation, no member of the Committee shall be entitled to any remuneration or expenses in respect of his or her service as a member of the Committee."
- **6.** New Schedule of licence fees substituted—(1) The principal regulations are hereby amended by revoking the Second Schedule (as substituted by regulation 11 (1) of the Taupo Fishing Regulations 1984, Amendment No. 5), and substituting the Second Schedule set out in the First Schedule to these regulations.
- (2) Regulation 11 (1) of the Taupo Fishing Regulations 1984, Amendment No. 5 is hereby consequentially revoked.
- 7. New Fifth Schedule added—The principal regulations are hereby amended by adding the Fifth Schedule set out in the Second Schedule to these regulations.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2 inserts into the principal regulations definitions of the terms "Committee", "Department", and "Minister".

Regulation 3 amends regulation 10 of the principal regulations to restrict Taupo fishing licences to the Taupo District.

Regulation 4 amends regulation 20 of the principal regulations to impose a daily bag limit of 3 trout. The daily bag limit was formerly 8.

Regulation 5 inserts into the principal regulations new Part VIA (comprising new regulations 384 to 38H), which provide for the establishment and operation of the Taupo Fishery Advisory Committee.

Regulation 38_{A} provides for the Minister to establish the Committee and specifies its composition.

Regulation 38B specifies the functions of the Committee.

Regulation 38c provides that a member of the Committee holds office at the pleasure of the Minister.

Regulation 38D provides for the election of a Chairperson of the Committee.

Regulation 38E governs the conduct of meetings of the Committee.

Regulation 38F provides for other persons to attend meetings of the Committee.

Regulation 38g provides that the Department of Conservation shall service the Committee.

Regulation 38H provides for voting members of the Committee to be reimbursed for travelling expenses incurred by them on Committee business.

Regulation 6 substitutes in the principal regulations a new Schedule of licence fees. All of the fees are increased.

Regulation 7 adds to the principal regulations a new Fifth Schedule specifying the angling organisations that may be represented on the Committee under new regulation 38A (2) (a).
