ORDER IN COUNCIL

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 14 of the Maori Land Amendment and Maori Land Claims Adjustment Act 1926, and to sections 48 and 48A of the Conservation Act 1987, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title, commencement, and application—(1) These regulations may be cited as the Taupo Fishing Regulations 1984, Amendment No. 7, and shall be read together with and deemed part of the Taupo Fishing Regulations 1984* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of July 1992.

(3) These regulations shall apply in respect of all licences issued in respect of any period commencing on or after the 1st day of July 1992.

2. Interpretation—(1) Regulation 2 (1) of the principal regulations is hereby amended by omitting from the definition of the term "landmark" the word "black", and substituting the words "white, black,".

(2) Regulation 2 (1) of the principal regulations is hereby amended by repealing subparagraph (i) of paragraph (a) of the definition of the term "open season", and substituting the following subparagraph:

"(i) That portion of the Tongariro River between its source and a point being the usual site of a landmark that is 500 metres, more or less, upstream of the point where the river is joined by the Whitikau Stream:".

3. New Second Schedule substituted—(1) The principal regulations are hereby amended by revoking the Second Schedule (as substituted by regulation 6 (1) of the Taupo Fishing Regulations 1984, Amendment No. 6), and substituting the Second Schedule set out in the Schedule to these regulations.

(2) Regulation 6 of the Taupo Fishing Regulations 1984, Amendment No. 6 is hereby consequentially revoked.

Taupo Fishing Regulations 1984, Amendment No. 7

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 July 1992, amend the Taupo Fishing Regulations 1984.

Regulation 2 amends the definitions of the terms "landmark" and "open season".

The term "landmark" is amended to provide for the use of white, black, and yellow ringed posts and buoys. The term "open season" is amended to extend the winter fishing boundary on the

The term "open season" is amended to extend the winter fishing boundary on the Tongariro River by 500 metres upstream of the confluence of the river and the Whitikau Stream.

Regulation 3 increases the adult whole season licence fee by 1, increases the adult weekly licence fee by 50 cents, and increases the child day licence fee by 40 cents.
