THE TAUPO FISHING REGULATIONS 1984, AMENDMENT NO. 8

ORDER IN COUNCIL

At Wellington this 30th day of August 1993

Present:

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to section 14 of the Maori Land Amendment and Maori Land Claims Adjustment Act 1926, and to sections 48 and 48A of the Conservation Act 1987, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title, commencement, and application—(1) These regulations may be cited as the Taupo Fishing Regulations 1984, Amendment No. 8, and shall be read together with and deemed part of the Taupo Fishing Regulations 1984* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 1st day of October 1993.
- (3) These regulations shall apply in respect of all licences issued in respect of any period commencing on or after the 1st day of October 1993.
- 2. Interpretation—Regulation 2 (1) of the principal regulations is hereby amended by revoking subparagraph (ii) of paragraph (a) of the

definition of the term "open season", and substituting the following subparagraph:

- "(ii) That portion of the Waiotaka River between its source and the point being the usual site of a landmark approximately 150 metres upstream of the point where the Waiotaka Road meets the river:"
- **3. Fishing prohibited in certain waters**—Regulation 3 (1) of the principal regulations is hereby amended by adding the following paragraphs:

"(q) All tributaries of the Waitahanui River, except the Mangamutu

Stream:

- "(r) All tributaries of the Mangamutu Stream:
- "(s) All tributaries of the Waiotaka River:
- "(t) All tributaries of the Whanganui Stream:
- "(u) The Tutaeuaua Stream:
- "(v) The Otutira Stream:
- "(w) The Otaketake Stream:
- "(x) The Waitotara Stream:
- "(y) The Waipehi Stream:
- "(z) The Te Whaiau Stream, including the Whanganui River diversion outfall."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 October 1993, amend the Taupo Fishing Regulations 1984.

Regulation 2 amends the definition of the term "open season" in regulation 2 (1) of the principal regulations by moving the winter fishing boundary on the Waiotaka River approximately 150 metres upstream.

Regulation 3 adds certain spawning waters to the list of prohibited fishing waters in regulation 3 (1) of the principal regulations.
