Pursuant to the Tobacco Growing Industry Act 1935, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations:

REGULATIONS

- 1. These regulations may be cited as the Tobacco Growing Industry Regulations 1945, Amendment No. 17, and shall be read together with and deemed part of the Tobacco Growing Industry Regulations 1945* (hereinafter referred to as the principal regulations).
- 2. Paragraph (c) of regulation 41 of the principal regulations is hereby amended by omitting the words "resident in the ward where the crop is situated".
- 3. (1) The principal regulations are hereby amended by revoking regulation 53 (as substituted by regulation 3 of the Tobacco Growing Industry Regulations 1945, Amendment No. 13) and substituting the following regulation:

- (2) Compensation at the rates specified in regulation 53 of the principal regulations (as substituted by subclause (1) of this regulation) may be paid in respect of the season beginning in the year 1965 and ending in the year 1966 and in respect of subsequent seasons.
- (3) Regulation 3 of the Tobacco Growing Industry Regulations 1945, Amendment No. 13, is hereby revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2 omits a provision requiring an assessor appointed to inspect a crop in respect of which a claim for compensation is made to reside in the ward where the crop is situated.

Clause 3 increases the amount which may be assessed as the value of a crop in respect of which compensation is payable.
