PURSUANT to the Tobacco Growing Industry Act 1935, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Tobacco Growing Industry Regulations 1945, Amendment No. 18, and shall be read together with and deemed part of the Tobacco Growing Industry Regulations 1945* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations increase the fees payable to panel assessors from 80c to \$1 an hour for assessing damage to tobacco crops.

Issued under the authority of the Regulations Act 1936.
