ORDER IN COUNCIL

At the Government House at Wellington this 17th day of December 1973

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Transport Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title—These regulations may be cited as the Transport (Commonwealth Games) Regulations 1973.

2. Suspension of existing law—For the purpose of facilitating the conveyance to or from the opening ceremonies of the Commonwealth Games at Christchurch on the 24th day of January 1974, or to or from rehearsals for such ceremonies, of children and other persons taking part in those ceremonies or rehearsals, any motor vehicle and the owner and the driver of any motor vehicle for the time being in use for the carriage of those children and other persons shall be exempted from the following requirements, namely:

- (a) Any requirements as to licensing of Part VII of the Transport Act 1962; and
- (b) As to the driver, from regulation 3 of the Motor Drivers' Regulations 1964*, so far as it requires that the driver shall be the holder of a motor-driver's licence other than the class of licence required to be held by the driver of that vehicle during its ordinary use; and
- (c) As to the vehicle, from the provisions of section 143 of the Transport Act 1962, unless the vehicle is already subject to the provisions of that section:

- (d) As to the vehicle, from the requirements of regulation 8 of the Motor Vehicles Registration and Licensing Regulations 1965†, that there shall be displayed on the vehicle a licence label other than the licence label required to be displayed on that vehicle during its ordinary use; and
- (e) As to the vehicle, from the requirements of regulation 6 of the Motor Vehicles Insurance (Third Party Risks) Regulations 1963‡ requiring the classification of that vehicle in a class higher than the class in which it is classified during its ordinary use.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations are for the purpose of facilitating the transport of children and others taking part in the opening ceremonies of the Commonwealth Games to and from the opening ceremonies and any necessary rehearsals.

Issued under the authority of the Regulations Act 1936.

Date of notification in *Gazette*: 19 December 1973.

These regulations are administered in the Ministry of Transport.
