ORDER IN COUNCIL

At the Government House at Wellington this 26th day of September 1977

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Transport Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Transport (Auckland Harbour Ferry Services) Order 1977.

(2) This order shall come into force on the 1st day of April 1978.

2. Auckland Harbour-ferry Service District—It is hereby declared that the Auckland Harbour shall be a harbour-ferry service district for the purposes of Part VII of the Transport Act 1962 with the name of the Auckland Harbour-ferry Service District, and that the provisions of the said Part VII shall apply to the harbour-ferry services specified in the Schedule hereto:

Provided that nothing in this order shall apply to any harbour ferry carrying passengers for the Auckland Harbour Board, the Customs Department, the Police, or any shipping company under a contract expressed or implied for the use of the vessel as a whole.

SCHEDULE

HARBOUR-FERRY SERVICES TO WHICH PROVISIONS APPLY

1. All harbour-ferry services between Auckland and the boroughs of Birkenhead, Devonport, and Northcote, and the City of Takapuna, or between any one of the said boroughs or city and any other or others of the said boroughs or city.
2. All harbour-ferry services between Auckland and Pine Island.
3. All harbour-ferry services between Rangitoto Island and any other place within the Auckland Harbour-ferry Service District.
4. All harbour-ferry services between Waiheke Island and any other place within the Auckland Harbour-ferry Service District.
5. All harbour-ferry services between Motutapu Island and any other place within the Auckland Harbour-ferry Service District.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 April 1978, consolidates and amends the Transport (Auckland Harbour-Ferry Services) Order 1949 and its amendments.

The only change is to include services between Motutapu Island and any other place in the Auckland Harbour-ferry Service District. The effect of this will be that those services will require to be licensed under Part VII of the Transport Act 1962 and the fares chargeable will be fixed in accordance with the provisions of that Part.
