THE TECHNICAL INSTITUTE BURSARIES REGULATIONS 1966, AMENDMENT NO. 3

Pursuant to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title—These regulations may be cited as the Technical Institute Bursaries Regulations 1966, Amendment No. 3, and shall be read together with and deemed part of the Technical Institute Bursaries Regulations 1966* (hereinafter referred to as the principal regulations).
- 2. Award of bursaries—Regulation 3 of the principal regulations (as amended by regulation 2 of the Technical Institute Bursaries Regulations 1966, Amendment No. 1) is hereby further amended by omitting from subclause (2) the words "Group 1, Group 2, Group 3 (a), and Group 3 (b)", and substituting the words "Step 1, Step 2, Step 3, and Step 4".
- 3. Value and tenure of bursaries—(1) Regulation 17 of the principal regulations (as amended by regulation 7 of the Technical Institute Bursaries Regulations 1966, Amendment No. 1) is hereby further amended by revoking paragraphs (a) to (d) of subclause (1), and substituting the following paragraphs:
 - "(a) \$20 in respect of a Step 1 course of instruction:
 - "(b) \$80 in respect of a Step 2 course of instruction:
 - "(c) \$120 in respect of a Step 3 course of instruction:
 - "(d) \$165 in respect of a Step 4 course of instruction."

- (2) The said regulation 17 is hereby further amended by revoking subclause (7), and substituting the following subclause:
- "(7) The maximum annual value of a boarding allowance payable with a bursary shall be as follows:
 - "(a) \$300 for a Step 1 course of instruction:
 - "(b) \$350 for a Step 2, Step 3, or Step 4 course of instruction."
- 4. Supplementary allowances—The principal regulations are hereby further amended by inserting, after regulation 17, the following regulation:
- "17a. (1) A supplementary allowance of the maximum value of \$100 a year may be awarded by the Director-General for 1 year only to a student who in or after the year 1972,—
 - "(a) Has in the same year obtained A passes in all subjects of the Year III syllabus for a New Zealand Certificate, and in the next following year has enrolled in, and has after completion of the first term of work made in the opinion of the Director-General satisfactory progress in, all subjects of the Year IV syllabus of the New Zealand Certificate; or
 - "(b) Being a bursar in a Step 2 course of instruction, has passed at a high standard, to be determined by the Director-General, in all the subjects of that course in the same year of examination conducted externally of a technical institute at a national level and recognised by the Director-General for the purposes of this paragraph, and in the next following year has enrolled in, and has after completion of the first term of work made in the opinion of the Director-General satisfactory progress in, a Step 3 course of instruction.
- "(2) Notwithstanding anything in subclause (1) of this regulation, the Director-General may at his discretion award a supplementary allowance under paragraph (b) of subclause (1) to a student in a full-time course of instruction where there is no national external examination recognised for the purposes of that paragraph.
- "(3) A supplementary allowance of the maximum value of \$60 a year may be awarded by the Director-General for 1 year only to a student who in or after the year 1972—
 - "(a) Has in the same year obtained B level passes or better in all subjects in the Year III syllabus for a New Zealand Certificate, and in the next following year has enrolled in, and has after completion of the first term of work made in the opinion of the Director-General satisfactory progress in, all the subjects of the Year IV syllabus of the New Zealand Certificate; or
 - "(b) Being a bursar in a Step 2 course of instruction, has obtained in the same year B level passes in all the subjects of an examination conducted externally of a technical institute at a national level and recognised by the Director-General for the purposes of this paragraph, and in the next following year has enrolled in, and has after completion of the first term of work made in the opinion of the Director-General satisfactory progress in, a Step 3 course of instruction.

- "(4) Notwithstanding anything in subclause (3) of this regulation, the Director-General may at his discretion award a supplementary allowance under paragraph (b) of subclause (3) to a student in a full-time course of instruction where there is no national external examinaion recognised for the purposes of that paragraph.
- "(5) A supplementary allowance shall be payable in addition to other payments payable to bursars under these regulations."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Technical Institute Bursaries Regulations 1966. The maximum value of bursaries relating to certain courses of instruction is increased. The maximum annual value of boarding allowances is increased. Provision is made for the payment of supplementary allowances.
