**THE TRANSPORT (SPEEDING INFRINGEMENTS) NOTICE
1972**

PURSUANT to section 42 of the Transport Act 1962 (as inserted by section 2 of the Transport Amendment Act 1970 and amended by section 5 of the Transport Amendment Act 1972), the Minister of Transport hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Transport (Speeding Infringements) Notice 1972.

(2) This notice shall come into force on the 1st day of December 1972.

2. Speeding-infringement notice—Every speeding-infringement notice under the said section 42 of the Transport Act 1962 shall be in the form set out in the First Schedule to this notice.

3. Speeding-infringement fees—The fees specified in the Second Schedule to this notice are hereby prescribed as the speeding-infringement fees payable under the said section 42 of the Transport Act 1962.

4. Revocation—The Transport (Speeding Infringements) Notice 1971* is hereby revoked.

FIRST SCHEDULE—*continued*

1. If the fee is not paid before the date specified in this notice, proceedings for failure to pay may be taken under the Summary Proceedings Act 1957 for an offence under section 42 (9) of the Transport Act 1962 which reads:

“Every person commits an offence against this Act, who, having committed a speeding infringement, and having been served, not later than 6 months after the date of the commission of that infringement, with a speeding-infringement notice relating to that infringement, fails to pay to the enforcement authority before the date specified in the notice the appropriate speeding-infringement fee payable in respect of that infringement.”

2. If you pay the fee and the speeding infringement was a breach of a speed limit which applied to all motor vehicles, demerit points will be recorded against you as if you had been convicted on the date of payment of the speeding offence which constitutes the speeding infringement.

3. If proceedings are taken against you for an offence against section 42 (9) of the Transport Act 1962, then,—

(a) Without restricting any other defence that you may consider you have, you are entitled to defend the charge on the ground that you did not commit the alleged speeding infringement:

(b) If you satisfy the Court, either by evidence at the hearing or by a statement in writing delivered or sent to the Registrar of the Court, that, for special reasons relating either to the speeding infringement or to the failure to pay the speeding-infringement fee or to yourself, the amount of that fee is excessive, the Court may reduce the amount of the speeding-infringement fee.

4. [*When the notice is issued by an officer of the Ministry of Transport.*] Payments by cheque, money order, or postal note should be made out to “Ministry of Transport”, and may be delivered or posted to any Ministry of Transport office. Cheques and money orders should be marked “Not Negotiable”.
