

## THE TECHNICAL INSTITUTES REGULATIONS 1968, AMENDMENT NO. 3

Pursuant to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

- 1. Title—These regulations may be cited as the Technical Institutes Regulations 1968, Amendment No. 3, and shall be read together with and deemed part of the Technical Institutes Regulations 1968\* (hereinafter referred to as the principal regulations).
- **2.** Appointment of Deputy Principal—(1) Regulation 11 of the principal regulations is hereby amended by omitting from subclause (1) the words "with the approval of the Director-General".
- (2) The said regulation 11 is hereby further amended by omitting from subclause (2) the words "Subject to the approval of the Director-General,".
- 3. Appointment of Heads of Departments—Regulation 12 of the principal regulations is hereby amended by omitting the words "Subject to the approval of the Director-General,".
- 4. Travelling expenses and travelling allowances—Regulation 24 of the principal regulations is hereby amended by omitting the words "with the prior approval of the Director-General", and substituting the words "with the prior approval of the Board".

5. Expenditure of grants for general expenses—Regulation 59 of the principal regulations is hereby amended by revoking paragraph (i), and substituting the following paragraph:

"(i) Refund of reasonable expenses incurred by any tutor or other officer who at the request of the Board attends an educational conference or meeting, and who has the prior approval of the Minister if the conference or meeting is overseas:"

## EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Technical Institutes Regulations 1968. The main effect is that the appointment by the Board of Governors of a technical institute of a Head of Department in the institute to the position of Deputy Principal will no longer require the prior approval of the Director-General of Education. Appointments to the position of Head of Department will likewise no longer require the prior approval of the Director-General. Prior approval of the Director-General will no longer be required for the refund of reasonable expenses incurred by a tutor or other officer of a technical institute who at the request of the Board of Governors of the institute attends an educational conference or meeting. If the conference or meeting is overseas, however, the prior approval of the Minister of Education will still be required.
