THE TRANSPORT LICENSES EMERGENCY REGULATIONS 1942. AMENDMENT NO. 2

ORDER IN COUNCIL

At the Government House at Wellington, this 7th day of March, 1945

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Transport Licenses Emergency Regulations 1942, Amendment No. 2, and shall be read together with and deemed part of the Transport Licenses Emergency Regulations 1942* (hereinafter referred to as the principal regulations).

2. Regulation 8 of the principal regulations is hereby amended by revoking subclause (1), and substituting the following subclause :---

"(1) Notwithstanding anything to the contrary in subsection (1) of section 2 of the Transport Licensing Amendment Act, 1935, or in subclause (1) of clause $1\overline{4}$ of the Schedule to the Transport (Goods) Applied Provisions Order 1942⁺,---

- (a) Every goods-service license issued pursuant to the provisions
 - of the Transport (Goods) Emergency Regulations 1943; now or at any time hereafter in force (not being a temporary license) shall continue in force until the first quarter-day following the termination of the present war or until the date at which the license is expressed to expire, whichever date is the later, unless the license is sooner revoked. or unless it expressly provides that this regulation shall not apply to it :
- "(b) Every other goods-service license or passenger-service license now in force (not being a temporary license) shall expire on the 28th day of March, 1945, unless the license is sooner renewed as from that date or is sooner revoked :

"Provided that this subclause shall not apply with respect to any license that is duly suspended as at the said 28th day of March, 1945, whether under these regulations or otherwise."

3. The Transport Licensing Emergency Regulations 1940* and the Transport Licensing Emergency Regulations 1940, Amendment No. 1[†] (which relate to the shortening of the time of notice for reviews and appeals in respect of passenger-services and goods-services), are hereby revoked.
