TRANSPORT LICENSING PASSENGER REGULATIONS 1936, AMENDMENT NO. 8

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Transport Licensing Act, 1931, His Excellency the Governor-General doth hereby make the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Transport Licensing Passenger Regulations 1936, Amendment No. 8.
- 2. These regulations shall be read together with and deemed part of the Transport Licensing Passenger Regulations 1936* (hereinafter called the principal regulations).
- 3. These regulations shall come into force on the day next following the notification in the *Gazette* of the making thereof.
- 4. (1) Regulation 19 of the principal regulations, as amended by Regulation 4 of the Transport Licensing Passenger Regulations 1936, Amendment No. 4, is hereby further amended by revoking paragraph (i) of clause (2) thereof, and substituting the following paragraph:—
 - "(i) In addition to the payments authorized by clause (1) of this regulation there shall be paid to each member of a Licensing Authority for every day or part of a day on which he is occupied or engaged on the business of the
