## THE TRANSPORT LICENSING (GOODS-SERVICE) REGULA-TIONS, 1936.

Enacting authority: His Excellency the Governor-General in Council.

Act pursuant to which the regulations were made : Section 59 of the Transport Licensing Act, 1931, and all other powers enabling in that behalf.

Date on which the regulations were made : 22nd day of October, 1936. Date of notification in *Gazette* : 22nd day of October, 1936.

## 170 Transport Licensing (Goods-service) Regulations, 1936.

(2) These regulations may be cited as the Transport Licensing (Goods-service) Regulations, 1936.

(3) These regulations shall come into force on the day following notification in the *Gazette* of the making hereof.

- (4) In these regulations, unless inconsistent with the context,—
  - "Applied provisions" means the applied provisions of the Transport (Goods) Order, 1936:
  - "Enforcement Officer" means any member of the police force or the Commissioner, or any person appointed by the Commissioner, or by a Metropolitan Authority in terms of section fifty-four of the said Act:
  - "Fee" means the fee prescribed by Regulation 15 hereof:
  - "Goods-service vehicle" means a vehicle used under authority of a license :
  - "In form T.L. . . " means in the form set out in the Schedule hereto and prefixed by such respective number or to the effect of that form:

"License" means a license to carry on a goods-service :

- "Licensee" means the holder of a goods-service license :
- "Licensing Authority," in relation to a controlled area, means a Licensing Authority appointed therefor pursuant to the said Act.

"The said Act" means the Transport Licensing Act, 1931:

- "Variation" in respect of a goods-service license includes any amendment or revocation of any of the terms or conditions of such license, or any addition of new terms and conditions thereto, pursuant to clause 15 of the applied provisions:
- "Vehicle authority" means a vehicle authority issued under Regulation 4 hereof.

(5) The respective regulations next hereinafter referred to are revoked.

#### REGULATIONS REVOKED.

(6) All registers, appointments, licenses, vehicle authorities, applications, notices, matters and things which originated under any regulations heretofore in force and are effective on the coming into force of these regulations shall enure for the purposes of these regulations as if they had originated under these regulations, and shall, where necessary, be deemed to have so originated.

## REGULATION 2.—LICENSING PROCEDURE.

(1) The Licensing Authority may in its proceedings under these regulations act upon such information as it thinks fit, whether such information would be evidence legally admissible in judicial proceedings or not.

(2) Any person may be represented at such proceedings by counsel, solicitor, or other agent.

(3) The Licensing Authority may require any person to transcribe or summarize in writing either during or after the proceedings any oral statement made by such person during the proceedings.

# Regulation 3.—Application for a New License to carry on a Goods-service.

(1) Every application for a continuous or seasonal license, other than for a renewal of such license, shall be made in form T.L. 21A or T.L. 21B as may be appropriate, and in every case shall be accompanied by the appropriate fee, and shall be addressed and forwarded as required by and under clause 4 of the applied provisions.

(2) Every application for a temporary license shall be made orally or in writing to the Secretary of the Licensing Authority, or to a postmaster or other officer authorized to issue such licenses, and the provisions of Regulation 16 hereof shall apply in respect of such oral or written application.

## Regulation 4.—Goods-service Licenses and Vehicle Authorities.

(1) Every license other than a temporary license shall be issued in form T.L. 22A or T.L. 22B as may be appropriate, and, together with every such license, there shall be issued by the Licensing Authority a vehicle authority or vehicle authorities in form T.L. 23A or T.L. 23B as may be appropriate, to the number authorized by the license.

(2) It shall be a condition of every continuous or seasonal license (whether inserted therein or not) that on each goods-service vehicle while being used under the terms of such license there shall be carried the vehicle authority or one of the vehicle authorities issued with the license, and such vehicle authority shall be produced for inspection by the person for the time being in charge of the vehicle on demand by any Enforcement Officer.

(3) Save as otherwise provided by this regulation, each vehicle authority shall for the purposes of the said Act and the applied provisions and any regulations for the time being in force thereunder be deemed a substantive part of the license with which the authority is issued, and any conditions of a vehicle authority shall be deemed conditions of the license in the application of the license to the use of any vehicle on which the vehicle authority is being carried :

Provided that in proceedings for an offence under the said Act any license may be proved in terms of section 55 (c) of the said Act by production of a certified copy of that license without the vehicle authority or vehicle authorities issued therewith. (4) A separate license shall be issued in form T.L. 24 in respect of each vehicle to be used under the authority of a temporary license, and the appropriate fee shall be due on issue of the license.

(5) It shall be a condition of every temporary license (whether inserted therein or not) that the license be carried on the goods-service vehicle to which the license refers at all times whilst the vehicle is being used under the authority of a license, and the said license shall be produced for inspection by the driver of the vehicle on demand by any Enforcement Officer.

(6) It shall be a duty of the Secretary of each Licensing Authority to forward without delay to the Commissioner a record of every determination of the Licensing Authority in reference to a license or vehicle authority, and a copy, certified as correct, of each license or vehicle authority granted, and of each variation, suspension, or revocation thereof.

(7) The copies forwarded to the Commissioner in terms of the last preceding clause shall be recorded, and that record shall be the Register of Goods-service Licenses which is required to be kept by the Commissioner in terms of clause 19 of the applied provisions.

(8) It shall be a condition of every license (whether inserted therein or not) that, unless otherwise provided by the express terms of the license, the licensee shall upon request accept for transport, as authorized by the license, the goods of all persons conveniently served by him without discrimination among the hirers or in the charges levied.

(9) It shall be a condition of every license (whether inserted therein or not) that the following restriction shall apply unless otherwise provided by the express terms of the license :—

## Restriction.

If there is an available route for the carriage of goods which includes at least thirty miles of open Government railway, goods shall be carried by road only so far as is necessary to permit of their carriage by railway, unless the total distance of carriage by road and railway would be greater by more than one-third than the shortest road route available:

Provided that this restriction shall not apply to the carriage of fat lambs or to the carriage of such perishable goods as may be expressly described in the license, or to the carriage of goods on a route or routes or between terminal points expressly defined in the license.

#### REGULATION 5.—RENEWALS.

(1) Application for renewal of a license shall be made in duplicate in form T.L. 25A or T.L. 25B as may be appropriate, and shall be accompanied by the appropriate fee.

(2) Every application for renewal of a license shall, for the purposes of these regulations (other than the form of the application), be deemed an application for a new license.

(3) Every provision herein directed to be a condition of a license, whether inserted therein or not, shall be a condition of every license renewed after coming into force of these regulations whether or not it was a condition of the license prior to its renewal.

## Regulation 6.—Amendment, revocation, suspension, and Abandonment of License.

(1) Every application by the licensee under clause 15 of the applied provisions for the amendment or revocation of any of the terms or conditions of a license shall be in form T.L. 26, and shall be accompanied by the appropriate fee.

(2) The holder of any license which is lawfully revoked, suspended, amended, or which has lapsed, or of any license for a goods-service authorized to be discontinued, shall, upon request by the Secretary of the Licensing Authority which issued it, return to him within three days of such request the license and relative vehicle authorities, and if the license is amended a new license incorporating the amendment shall be issued or the original license with the amendment endorsed on it, or incorporated in form T.L. 27 and duly signed, shall be returned as soon as possible to the licensee together with such vehicle authorities (original, amended, or substituted) as may be appropriate.

(3) The revocation or suspension of a license shall be in form T.L. 28.

(4) When a goods-service has been abandoned by the licensee with the permission of the Licensing Authority duly obtained in terms of subclause (4) of clause 13 of the applied provisions, the relative license may be revoked by the Licensing Authority at any time after such permission has been given.

## REGULATION 7.—TRANSFER OF LICENSES.

(1) Every application for transfer of a license shall be made in duplicate in form T.L. 29, and shall be accompanied by the appropriate fee.

(2) If transfer of a license is granted it shall be sufficient evidence of the fact if the license and every vehicle authority relating thereto are endorsed to the following effect, and the endorsement is signed by the Secretary or member of the respective Licensing Authority :----

REGULATION 8.-REQUEST BY LICENSEE FOR REVIEW OF LICENSES.

(1) Any licensee who in his opinion is subjected to unfair competition from another licensed goods-service may request the Minister to direct the Licensing Authority to review the license authorizing that goods-service, as provided in clause 18 of the applied provisions.

(2) Upon receiving a request in terms of clause (1) hereof, the Minister may make such inquiries as he deems fit, and may then refuse or grant the request for a review of the respective license. If the request is granted, then the Minister shall direct the appropriate Licensing Authority to review the license in terms of clause 18 of the applied provisions.

## REGULATION 9.—APPEALS.

(1) Every appeal to the Minister from a decision of a Licensing Authority shall be commenced by petition in form T.L. 30, and shall, with the appropriate fee, be delivered to the Commissioner in duplicate (either personally or by registered letter addressed to the Commissioner) within twenty-one days after the date of the determination appealed against. No appeal shall be deemed to have been duly lodged unless it is accompanied by the respective fee.

(2) A copy of any correspondence or other documents relating to the subject-matter of the appeal and in the possession of the appellant shall be attached to the petition.

(3) Notification of receipt of the petition shall be forwarded by the Commissioner to the Licensing Authority concerned, and the Licensing Authority will thereupon cause to be forwarded to the Minister, through the Commissioner, a copy of any notes of evidence taken by the authority in connection with the subject-matter of the **a**ppeal.

(4) The Commissioner shall forward the papers relative to the appeal to the Minister.

(5) The Minister or any person appointed by him to inquire into any appeal (hereinafter referred to as "the examiner") may, in the hearing of an appeal, accept such evidence as he thinks fit, whether such evidence would be legally admissible in judicial proceedings or not.

(6) Save as hereinbefore provided, the Minister or the examiner shall determine his procedure in such manner as he thinks fit.

(7) A copy of the proceedings on appeal and of the decision of the Minister thereon shall as soon as possible after the determination of such proceedings be sent by the Minister to the Commissioner who shall thereupon notify the decision to the Licensing Authority concerned and every other body or person who in the opinion of the Commissioner is directly interested therein.

#### REGULATION 10.—VEHICLE-INSPECTION CERTIFICATES.

(1) It shall be a condition of every continuous or seasonal license (whether inserted therein or not) that on every goods-service vehicle while being used under the terms of the license there shall after the 31st day of December, 1936, be carried an inspection certificate issued in respect of that vehicle by an Inspector in form T.L. 31, and hereinafter described as a "certificate."

(2) Application for a certificate shall be made in form T.L. 32, and, if possible, at least fourteen days before it is required.

(3) If a period of six months has elapsed since the date recorded on the certificate as being its commencing-date the Commissioner or Inspector may require that the certificate be forwarded or handed to the Inspector; or, if on inspection of the vehicle by an Inspector he considers that it is unfit for service, the Commissioner or Inspector may by notice in writing to the licensee require that the certificate be forwarded or handed by the licensee to the Inspector, and the licensee shall forthwith forward or hand the certificate to the Inspector accordingly. At any time after the making of such requirement or the giving of such notice the Inspector may remove the certificate from the vehicle provided that if the certificate is removed during a journey authorized by the license it shall not then be a breach of the provisions of clause (1) hereof for the driver of the vehicle to complete the journey and return the vehicle to its place of garage without carrying the certificate.

(4) It shall be an offence under these regulations for the licensee or for any person for the time being in charge of the vehicle to use or permit to be used under the license any vehicle which with its load exceeds the maximum gross weight set out for that vehicle in the respective certificate.

(5) Prior to the delivery of a certificate to the applicant or his agent there shall be payable by the licensee the appropriate fee.

(6) The certificate while in force and use shall be kept in good and legible condition.

(7) The certificate shall on request by an Inspector or Enforcement Officer be produced by the person for the time being in charge of the vehicle for inspection or for removal.

## REGULATION 11.—ACCOUNTS AND RETURNS.

The Commissioner may require any licensee to keep such records and to maintain such an accounting system as will enable him to make on request of the Commissioner the statistical and financial returns described in form T.L. 33 for the purposes of clause 4 of the applied provisions or any other lawful purpose.

#### REGULATION 12.—DRIVING-HOURS.

(1) It shall be a condition of every license (whether inserted therein or not) that unless otherwise provided in the license the licensee shall not drive or cause or permit any person employed by him or subject to his orders to drive any goods-service vehicle used under the authority of a license—

- (i) For any continuous period of more than five and one-half hours; or
- (ii) For continuous periods amounting in the aggregate to more than eleven hours in any period of twenty-four hours; or
- So that the driver has not at least ten consecutive hours for rest in any period of twenty-four hours; or
- (iv) So that the driver has not at least twenty-four consecutive hours for rest in any period of seven days.

(2) For the purposes of the condition set out in the last preceding clause hereof,—

- (a) Any two or more periods of time shall be deemed to be a continuous period unless separated by an interval of not less than half an hour in which the driver is able to obtain rest and refreshment; and
- (b) Any time spent by a driver on any work in connection with a goods-service vehicle or the load carried thereby shall be reckoned as time spent in driving.

(3) Nevertheless, a licensee shall not be liable to be convicted for breach of the condition set out in clause (1) of this regulation if he proves to the Court that the contravention was due to unavoidable delay in the completion of any journey arising out of circumstances which he could not reasonably have foreseen.

## 176 Transport Licensing (Goods-service) Regulations, 1936.

(4) It shall also be a condition of every license (whether inserted therein or not) that, unless otherwise provided in the license, a time-book in the form or to the effect of the form contained in clause (5) of this regulation, or a combination of time-books to the like effect, shall be kept in respect of every driver and other person (including the licensee) employed on every goods-service vehicle used under authority of such license (any such driver or person being hereinafter referred to as "the employee"). The hours at which every employee commences and ends work on any day and the periods for which such employee ceases work for the purpose of rest and refreshment shall be entered in the time-book from day to day by every employee. At the end of each week the amount of wages paid in each case, or the amount of any drawings by the licensee in lieu of wages in respect of that week, shall also be recorded in the place provided for that All time-books aforesaid shall be available for inspection purpose. by any Enforcement Officer at any reasonable time during a period of six months next ensuing from the date to which they refer.

(5) The time-book required to be kept under this regulation shall be as follows:—

## REGULATION 13.—WAGES.

It shall be a condition of every license (whether inserted therein or not) that, unless otherwise provided in the license, the licensee shall pay every person employed by him to drive any goods-service vehicle used under the authority of such license not less than the wages prescribed for such employee in any award or awards from time to time in force and made by order of the Arbitration Court under the Industrial Conciliation and Arbitration Act, 1925. This condition shall apply in respect of all licenses, whether or not the licensees or their employees are parties to such award or awards.

## Regulation 14.—Altering, defacing, or parting with a Goodsservice License, and issue of Duplicates therefor.

(1) For the purposes of this regulation "document" means any license or variation thereof, any vehicle authority, or any inspection certificate, and includes a duplicate of a document.

- (2) No person shall—
- (a) Save by direction of the Licensing Authority or person issuing it alter or deface any document, and any document so altered or defaced shall be void; or
- (b) Without authority of the Licensing Authority or the Commissioner, lend or part with any license or vehicle authority issued to him.

(3) Upon the return of any document rendered illegible or spoilt by weather or other such cause, or upon proof to his satisfaction that a document has been destroyed, stolen, or lost, the Commissioner of Transport, on application of the person to whom the document was issued, and on payment of the appropriate fee, may issue or cause to be issued a duplicate of such document. Every duplicate so issued shall have the word "duplicate" written or printed thereon, and the production of a duplicate document shall be of the same effect as the production of the original document.

## Regulation 15.—Fees.

(2) The prescribed fee, if  $\pounds 1$  or over, shall be paid on behalf of the person from whom it is due to the Reserve Bank of New Zealand, or any branch of the Bank of New Zealand, to the credit of the Public Account; and in respect of every application for a license, or for renewal, amendment, or transfer of a license, and every appeal, the bank receipt shall accompany the application or appeal.

(3) Notwithstanding anything hereintofore to the contrary, the whole or any portion of any fee or fees payable under this regulation may, on the certificate of the Commissioner of Transport, be refunded or remitted on either of the following grounds, namely :---

(a) That the application in respect of which the fee or fees are payable has been withdrawn, or that other action in respect of the application has been nullified, and that in consequence the work and expense of the Transport Department or any Licensing Authority has been reduced to an extent justifying the refund or remission; or

(b) That the goods-service in respect of which the fees are payable is used for the occasional carriage of goods only, or is used for the carriage of goods to such a limited extent that the full fees payable under the foregoing provisions of this clause would be disproportionate having regard to the amount of the goods-business.

## **Regulation 16.—Offences and Penalties.**

- (1) Every person who—
- (a) Knowingly supplies any false or misleading information in or concerning any application made in terms of these regulations; or
- (b) Omits or refuses to supply any information herein or in any form of application hereby prescribed required to be given by such person or given in such form of application notwithstanding that the form used by such person deviates from the respective form hereby prescribed-

shall be deemed to have committed a breach of these regulations.

(2) Every person who signs an application (including an appeal) not executed in person by the licensee, proposed licensee, or appellant without having authority from the licensee, proposed licensee, or appellant to make the application commits an offence against these regulations.

(3) Every person who—

- (a) Fails to comply with any condition, duty, or obligation imposed by the said Act or the applied provisions and for which no penalty is therein provided or imposed by these regulations or imposed in any license under these regulations; or
- (b) Offends against or fails to comply with or otherwise commits or permits a breach of any of these regulations-

shall be liable for every such breach to a fine not exceeding £10.




