**ORDER IN COUNCIL**

At the Government House at Wellington this 28th day of September  
1970

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Transport Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

**REGULATIONS**

**1. Title**—These regulations may be cited as the Transport Licensing Regulations 1963, Amendment No. 12, and shall be read together with and deemed part of the Transport Licensing Regulations 1963\* (hereinafter referred to as the principal regulations).

**2. Railway restriction**—Regulation 24 of the principal regulations is hereby amended by adding to paragraph (g) of subclause (3) (which paragraph was substituted by regulation 2 (1) of the Transport Licensing Regulations 1963, Amendment No. 10) the words “or straw”.

**3. Exemption from goods-service licensing**—Regulation 28 of the principal regulations (as substituted by regulation 3 of the Transport Licensing Regulations 1963, Amendment No. 9) is hereby amended by inserting in paragraph (f), after the word “hay”, the words “or straw”.

**4. Apportionment of taxicab fees**—(1) Regulation 71A of the principal regulations (as inserted by regulation 4 (1) of the Transport Licensing Regulations 1963, Amendment No. 8) is hereby amended by omitting from subclause (2) the words “the Wellington City Council”.

(2) This regulation shall come into force on the 1st day of October 1970.

#### EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

Regulations 2 and 3 exempt from the rail restriction and from transport-service licensing the carriage of straw by the owner thereof.

Regulation 4 excludes the Wellington City Council from the City Councils to which taxicab fees are payable. This is consequential on the transfer from the Council to the Ministry of Transport, as from 1 October 1970, of transport control in the City of Wellington (including vehicle inspection and the issue of certificates of fitness).
