THE RIGHT HON, R. D. MULDOON PRESIDING IN COUNCIL Pursuant to section 113 (2) of the Transport Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Transport Licensing Regulations 1963, Amendment No. 30, and shall be read together with and deemed part of the Transport Licensing Regulations 1963* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 14th day after the date of their notification in the Gazette.
- 2. Carriage of fresh grapes from grower to wine maker exempted from licensing—Regulation 28 of the Transport Licensing Regulations 1963 (as substituted by regulation 3 of the Transport Licensing

Regulations 1963, Amendment No. 9 and amended by various other regulations) is hereby further amended by revoking paragraph (s) (that was added by regulation 2 of the Transport Licensing Regulations 1963, Amendment No. 27 and expired on the 31st day of May 1982 in accordance with regulation 3 of those regulations), and substituting the following paragraph:

- "(s) Every goods service for the carriage of fresh grapes from the premises of the grower of the grapes to the premises of a wine maker during the period commencing on the 1st day of February 1983 and ending with the close of the 31st day of May in that year."

- **3. Revocation**—The Transport Licensing Regulations 1963, Amendment No. 27 are hereby revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations exempt from the transport licensing requirements of the Transport Act 1962 any goods service for the carriage of fresh grapes from the grower's premises to the premises of a wine maker during the period commencing on 1 February 1983 and ending with 31 May 1983.

Issued under the authority of the Regulations Act 1936. Date of notification in *Gazette:* 4 November 1982. These regulations are administered in the Ministry of Transport.
