HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 48 of the Transport (Vehicle and Driver Registration and Licensing) Act 1986, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Transport (Drivers Licensing) Regulations 1987, Amendment No. 3, and shall be read together with and deemed part of the Transport (Drivers Licensing) Regulations 1987* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 1st day of August 1988.
- 2. Fees—(1) Regulation 26F of the principal regulations (as inserted by regulation 3 of the Transport (Drivers Licensing) Regulations 1987, Amendment No. 1) is hereby amended by omitting from paragraph (a) the expression "\$25", and substituting the expression "\$27.50".

- (2) Regulation 26F of the principal regulations is hereby further amended by omitting from paragraph (b) the expression "\$15", and substituting the expression "\$16.50".
- **3. New Schedule of fees substituted**—The principal regulations are hereby amended by revoking the First Schedule, and substituting the First Schedule set out in the Schedule to these regulations.
- 4. Goods and services tax included—The principal regulations are hereby amended by revoking regulation 59A (as inserted by regulation 6 of the Transport (Drivers Licensing) Regulations 1987, Amendment No. 1), and substituting the following regulation:
- "59A. It is hereby declared that the fees fixed by these regulations are inclusive of any goods and services tax payable under the Goods and Services Tax Act 1985."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 August 1988, relate to fees payable under the Transport (Vehicle and Driver Registration and Licensing) Act 1986. A new fee is prescribed for approval as a driving instructor and many of the fees prescribed in the First Schedule to the principal regulations are increased. All fees prescribed by these regulations are inclusive of goods and services tax payable under the Goods and Services Tax Act 1985.

Issued under the authority of the Regulations Act 1936. Date of notification in *Gazette:* 28 July 1988. These regulations are administered in the Ministry of Transport.
