

# **Trade Marks Amendment Regulations 2006**

# Regulations

#### 1 Title

These regulations are the Trade Marks Amendment Regulations 2006.

#### 2 Commencement

These regulations come into force on 1 January 2007.

## 3 Principal regulations amended

These regulations amend the Trade Marks Regulations 2003.

## 4 Interpretation

The definition of **Nice Classification** in regulation 3 is amended by omitting "eighth edition of the Nice Classification published on 1 January 2002" and substituting "ninth edition of the Nice Classification published on 1 January 2007".

# Transitional provision for applications filed before 1 January 2007

- (1) This regulation applies to—
  - (a) an application for registration of a trade mark filed before 1 January 2007; and
  - (b) an action or other matter relating to an application referred to in paragraph (a), whether or not commenced before 1 January 2007.
- (2) For the purposes of clause (1)(b), an action or other matter includes, but is not limited to, an application under regulation 43 and the supply of information under regulation 44(c).
- (3) Every application, action, or other matter to which this regulation applies must be made, considered, and determined as if these regulations had not been made.

## **Explanatory note**

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 January 2007, amend the Trade Marks Regulations 2003.

The effect of the amendments is to—

- update the definition of Nice Classification so that the ninth edition of the Nice Classification of goods and services (to be published by the World Intellectual Property Organization on 1 January 2007) is applied to all trade mark applications filed on or after 1 January 2007:
- require all trade mark applications filed before 1 January 2007 to be made, considered, and determined in accordance with the law in force before 1 January 2007.
