Pursuant to the Milk Act 1944, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. (1) This order may be cited as the Thames Milk District Order 1963.
- (2) This order shall come into force on the day after the date of its notification in the Gazette.
- 2. The Thames Milk District, as constituted by the Thames Milk District Order 1960,* shall hereafter consist of the areas described in the Schedule hereto; and the boundaries of the said district shall be those specified in the said Schedule.
- 3. The Milk Authority for the said district shall continue to be the Thames Borough Council.
- 4. The Thames County Council, the Hauraki Plains County Council, and the Coromandel County Council shall each be entitled to have a representative on the Milk Committee of the Thames Borough Council and from time to time to nominate one person for that purpose.
- 5. The Thames Borough Council shall from time to time appoint to the Milk Committee of the Borough Council the persons nominated by the Thames County Council, the Hauraki Plains County Council, and the Coromandel County Council pursuant to clause 4 hereof.
 - 6. The Thames Milk District Order 1960 is hereby revoked.

SCHEDULE

THE THAMES MILK DISTRICT

ALL that area in the South Auckland Land District, Counties of Coromandel, Thames, and Hauraki Plains, Borough of Thames, bounded by a line commencing at the intersection of the southern boundary

of Papaaroha 3 with the mean high-water mark on the shores of the Hauraki Gulf in Block IA, Coromandel Survey District, and proceeding easterly and northerly along the said southern and the eastern boundaries of the said Papaaroha 3 to and along a right line to the southernmost corner of Papaaroha 5A 2B 2A 2 and along another right line to the southernmost corner of part Section 8, Block I, Coromandel Survey District, as shown on D.P. 11914; thence along the south-western boundary of another part of the said Section 8, as shown on D.P. 11619, crossing the intervening public road, and the south-western and southern boundaries of Section 11, Block I aforesaid, and that last-mentioned boundary produced to the eastern bank of the Waiwhango River; thence north-easterly generally along the south-eastern bank of the aforesaid river to the westernmost corner of Section 12, Block I aforesaid; thence south-easterly along the south-western boundaries of the said Section 12, to the southernmost corner of that section; thence south-easterly along a right line crossing a public road to the intersection of the south-eastern side of that road and the eastern side of the public road forming the eastern boundary of Section 10, Block I aforesaid; thence south-easterly generally along the generally southwestern boundaries of part Moehau 4 (provisional State forest, Gazette, 1933, page 1612), Section 6, Block II, Coromandel Survey District (provisional State forest, Gazette, 1937, page 1386), another part of Moehau 4, and part Whakanekeneke 2 (provisional State forest, Gazette, 1933, page 1612), crossing the intervening Kennedy Bay Road, to the northernmost corner of Allotment 22, Kapanga Parish, as shown on D.P. 1568; thence south-easterly along the south-western boundary of Section 28, Block II aforesaid, and the eastern boundary of Allotment 28, Kapanga Parish, to and along a right line to the northernmost corner of Section 4, Block VI aforesaid, and along the north-eastern boundary of that section, crossing the intervening Whangapoua Rcad, to the northern boundary of part Pukemaukuku Block, and along a right line to the westernmost corner of Section 10 (Trig. D), Block VI, Coromandel Survey District; thence southerly generally along the generally western boundaries of Sections 10 and 9, Block VI aforesaid, the northern and western boundaries of Waiau 1B to the right bank of the Waiau River; thence along a right line to the north-western corner of part Taurangakawau 4 and along the western boundary of the said part 4 to the south-eastern corner of Pukewhau; thence along a right line to the southernmost corner of Section 8A, Block X, Coromandel Survey District, and along the southern boundary of Section 13, Block X aforesaid, along a right line to the easternmost corner of Te Mata A, and along the north-western boundary of Section 3, Block XIV, Coromandel Survey District; and south-easterly along the south-western boundary of the said section, and westerly generally along the generally northern boundaries of Putaringa Block and southerly along the generally western boundaries of that block, Te Kakati, 4, 3, 2, 1, and again 2 and the eastern boundary of a line of road to its junction with the south-eastern boundary of Te Puke 4; thence westerly generally along a right line across the aforesaid line of road, to and along another part of the said south-eastern boundary to the westernmost corner of Te Puke 3; thence southerly down the middle of the Tupa Stream to and westerly down the middle of the Manaia River, and southerly up the middle of

the stream forming the western boundary of Manaia (1B and 2B) D 2B and across part Manaia (1B and 2B) D 2c and (1B and 2B) D 1 to its junction with the north-eastern boundary of Manaia (1B and 2B) E 1; thence south-easterly and south-westerly generally along the said northeastern boundary and south-eastern boundary of the aforesaid (1B and 2B) E 1 to the westernmost corner of Section 15, Block II, Hastings Survey District; thence south-easterly generally along the south-western boundary of that section and part Manaia (1B and 2B) E, the generally western boundaries of Sections 31 and 18, Block II aforesaid (State forest, Gazette, 1958, page 1075), crossing the intervening public road, to and along the generally western boundaries of Sections 19 and 20, Block II aforesaid, and part Section 13, Block VI, Hastings Survey District, and that last-named boundary produced to the middle of the Whakarewa Stream; thence down the middle of that stream to and up the middle of the Waikawau River to a point in line with the south-western boundary of Section 21, Block VII, Hastings Survey District; thence southerly generally along a right line to and along the said south-western boundary and the generally western boundaries of the aforesaid Section 21, to its southernmost corner; thence along a right line across the Te Mata River to and along the western boundaries of Section 9, Block XI, Hastings Survey District, the western boundary of Section 35 and its production to the middle of the Tapu River; thence up the middle of that river to a point in line with the western boundary of Waipatukahu 5B; thence along a right line across a public road to and along the said western boundary, the western boundary of Section 56, the generally western and southern boundaries of Section 39, the aforesaid sections being of Block XI aforesaid, and the last-mentioned boundary produced to the middle of the Puhoi Stream; thence down the middle of that stream to a point in line with the eastern boundary of Waiomu 3B 1A; thence still generally southerly along a right line to and along the said eastern boundary, the eastern boundary of Waiomu 3B 1B to and along the western boundary of Section 10 and its production across a public road, the Waiomu Stream, Crown land, and another public road to and along the western boundaries of Section 12, the aforesaid sections being of Block XIV, Hastings Survey District, the generally eastern boundaries of Te Puru 4B 1, 4B 4D, 4B 4B, and 4B 4A to and along the generally western and southern boundaries of Section 20, the western boundary of Section 19 to and along the north-western and south-western boundaries of Section 4, the aforesaid sections being of Block I, Thames Survey District, and the production of the last-mentioned boundary across Tararu Road to and down the middle of the Tararu Stream to and up the middle of the Ohio Stream to and easterly along the southern boundary of Block I, Thames Survey District, and southerly along the western boundary of Block V, Thames Survey District, to and along the generally western boundary of Section 1, Block V, Thames Survey District, the northern and generally western boundaries of part Karaka North 1 to and along the boundary of the Borough of Thames as described in Gazette, 1919, page 2479, to and north-easterly along the south-eastern boundaries of part Whakairorahi 1B and part Mangakirikiri South 3B, to and along the western boundary of part Te Ana 1 to a point in line with the southern boundary of Puketutu; thence easterly generally

along a right line across parts Te Ana 1 and 2 to and along the southern and generally eastern boundaries of the said Puketutu to and along the southern and eastern boundaries of Lot 2, D.P. 18557, and the production of the last-mentioned boundary across Lot 2, D.P. 18557, to and easterly generally along the generally southern boundary of Lot 1, D.P. 18557, the western end of a public road, the western boundary of Lot 8, D.P. 26519, the western and southern boundaries of part Section 11, Block V, Thames Survey District, along a right line across Kauaeranga Valley Road, to and along the generally southern boundary of another portion of the said Section 11 and its production to the middle of the Kauaeranga River; thence south-westerly generally down the middle of that river to a point in line with the eastern boundary of Part Te Poka 1; thence southerly generally along a right line to and along the said eastern boundary crossing the intervening public road, the southern boundary of part Pikiwahine, the generally western and southern boundaries of Hawaiki, the south-western boundaries of Lot 1, D.P. 28669, and the last-mentioned boundary produced to and down the middle of the Kirikiri River to a point in line with the south-western boundary of Lot 2, D.P. 28669; thence along a right line to and along the said south-western boundary, along a right line across a public road to and along the south-western boundary of Lot 3, D.P. 28669, to the southernmost corner of the said Lot 3; thence along a right line across Lot 1, D.P. 33945, to Trig. Station 28 in Block VIII. Thames Survey District, and the production of this right line across Motu-Horopapa to and southerly generally along the western and north-western boundaries of the north-western portion of Te Ahuroa 1A shown on D.P. 2180, the western boundary of Te Ahuroa 1c, the generally north-western and the south-western boundaries to Te Ahuroa 1F 3 to and along the north-western and south-western boundaries of Te Ahuroa 1E 7 crossing the intervening public road and southerly along the north-western and south-western boundaries of Tupanaki 2, the south-western and generally south-eastern boundaries at Tupanaki 3, to and along the south-western boundary of Ipuwhakatara and its production to and down the middle of the Matatoki Stream to and up the middle of the Mokopunukino Stream to and along the southern boundary of Section 16, Block XIII, Thames Survey District, to the southernmost corner of that section; thence along a right line across Lots 2 and 3, D.P. 28269, to and along the southern boundaries of Takainikau, the generally western boundaries of part Herekaki Okumara to and along the north-western and south-western boundaries of Te Rata 3A, the south-western and south-eastern boundaries of part Herekaki Okumara shown on D.P. 27923, again along the generally western boundaries of part Herekaki Okumara, the generally western boundaries of Whareorata, Whatumata, and Tieke 1 and the production of the last-mentioned boundary across a public road to and easterly along its southern side to and along the western boundary of Karongaronga South and its production to the middle of the Puriri River; thence easterly up the middle of that river to a point in line with the south-western boundary of Lot 300, Deeds Plan H 18; thence southeasterly generally along a right line to and along the said south-western boundary and its production across Puriri Valley Road to and along the south-western boundary of Lot 300A, Deeds Plan H 18, and its

production across part Old Land Claim 444 to and along the southwestern boundary of Lot 304, Deeds Plan H 18, to and southerly along the western and south-western boundaries of Te Horete 2B, the southwestern boundary of part Section 3, Block XIII, Thames Survey District, to and north-easterly generally along the south-eastern boundary of the said part Section 3, Lot 1, D.P. 30031, another part of the said Section 3, Lot 2, D.P. 30031, and a right line across a public road to the northernmost corner of Lot 2, D.P. S. 3088; thence south-easterly generally along the generally north-eastern boundary of the said Lot 2. to and north-easterly along the north-western side of a public road to a point in line with the north-eastern boundary of Lot 3, D.P. S. 3088; thence southerly generally along the abutment of a public road, the generally eastern boundaries of the said Lot 3 and Lot 3, D.P. S. 3829, crossing the intervening public road to a point in line with the eastern boundary of Omahu West 2B 2A 2; thence southerly along a right line to and along the said eastern boundary crossing the intervening Omahu Valley Road, to and along the northern bank of the Omahu Stream to a point in line with the western boundary of Section 6, Block I, Ohinemuri Survey District; thence southerly along a right line, crossing a public road, to and along the said western boundary, the western and southern boundaries of Section 11, all the aforesaid sections being of Block I, Ohinemuri Survey District, to and southwesterly and westerly along the south-eastern and southern boundaries of Section 2, Block IV, Waihou Survey District, crossing the intervening Onetai Road, to and southerly and easterly along the western and southern boundaries of Section 7, Block I, Ohinemuri Survey District, to the north-western corner of Section 8, Block I aforesaid; thence southerly generally along the western boundary of the said Section 8, the generally western boundaries of Hikutaia IG 4 to and southerly along the eastern boundaries of Blocks IV and VIII, Waihou Survey District, to the middle of the Hikutaia River; thence down the middle of that river and southerly up the middle of the Waihou River to a point in line with the northern side of State Highway No. 2 in Block XII, Waihou Survey District; thence westerly along a right line to and along the said northern side and the eastern side to the south-western corner of part Lot 1, D.P. 11081; thence westerly along a right line across the said State highway to and along the northern side of School Road to the south-western corner of part Section 3, Block XI, Waihou Survey District, as shown on D.P. 18292; thence northerly along the western boundary of the said part Section 3 and that boundary produced to its junction with the southern side of Fishers Road in Block VII, Waihou Survey District; thence westerly along a right line to the westernmost corner of Section 13, Block VII, Waihou Survey District, and the last-named right line produced to and northerly down the middle of the Awaiti Canal, to a point in line with the north-western boundary of Section 41, Block VI, Waihou Survey District; thence along a right line across a public road to and along the north-western boundary of Section 41, to and north-westerly generally along the north-eastern boundary of Section 24, the aforesaid sections being of Block VI, Waihou Survey District, and the production of the last-mentioned boundary across a public road to and down the middle of the Piako River to and up the middle of the Puhanga Canal

to a point in line with the northern side of Phillips Road; thence westerly along a right line across a public road to and along the said northern side to and northerly generally along the eastern boundary of Section 21, Block I, Waihou Survey District, and its production across Orchard West Road and part Section 17 to and westerly along the generally northern boundaries of the said part Section 17 to and along the southern and eastern boundaries of Lot 2, D.P. 12494, to and along the north-western boundary of part Section 37 and its production across State Highway No. 2 to and northerly along its eastern side to and along the south-eastern boundaries of part Section 28 and Section 29, all the aforesaid sections being of Block I, Waihou Survey District, and along the production of the last-mentioned boundary across River Road to and southerly along its eastern side and that side produced to and up the middle of the Piako River to a point in line with the southern boundary of Section 15, Block II, Waihou Survey District; thence easterly along a right line along the southern end of a public road to and along the southern boundaries of the said Section 15, Section 14, part Section 13, another part of Section 13 shown on D.P. 17010, all the aforesaid sections being of Block II, Waihou Survey District, along a right line across the Kopuarahi-Kerepehi road to and along the southern boundaries of Lot 1, D.P. 33010, Lot 3, D.P. S. 5455 and Lot 1, D.P. 12921, and the production of the lastmentioned boundary across Lots 1 and 2, D.P. S. 4525, to and northerly generally along the eastern boundaries of the said Lot 2, and Lot 2, D.P. 12921, Sections 29, 14, and 26, crossing the intervening Piako Road, the eastern boundaries of part Section 13 and Section 22A, all the aforementioned sections being of Block XI, Thames Survey District, and the production of the last-mentioned boundary across Ngataipua Road and Lot 1, D.P. 31694, to a point in line with the south-eastern boundary of Lot 1, D.P. 17786; thence along a right line to the southernmost corner of the said Lot 1; thence, again northerly, along the eastern boundary of Lot 3, D.P. 31694, the eastern boundaries of Lot 1, D.P. 31694, and Lots 3 and 1, D.P. 9708, Lot 1, D.P. S. 1048, crossing the intervening State Highway No. 25, the north-eastern boundary of Lot 4, D.P. S. 1048, and its production to and north-easterly and south-easterly along the mean high-water mark of the Firth of Thames and the left bank of the Waihou River to and along the middle of the Hauraki Bridge to and northerly generally along the right bank of the Waihou River and the mean high-water mark of the Firth of Thames and the Hauraki Gulf to and along the south-eastern boundary of Matariki in Block XIIIA, Coromandel Survey District, to and again northerly generally along the mean high-water mark of the Hauraki Gulf to the point of commencement.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect. This order redefines the Thames Milk District so as to include part of the County of Coromandel. It also entitles the Coromandel County Council to have a representative on the Milk Committee of the Thames Borough Council.
