Pursuant to the Patents, Designs, and Trade Marks Act, 1921–22, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. (1) These regulations may be cited as the Trade Marks Regulations 1941, Amendment No. 3, and shall be read together with and be deemed part of the Trade Marks Regulations 1941* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 1st day of September, 1951.
- 2. The First Schedule to the principal regulations is hereby amended as follows:—
 - (a) By omitting from item 1 the amount "£0 15s. 0d.", and substituting the amount "£2 0s. 0d.":
 - (b) By omitting from item 1A the amount "£0 15s. 0d.", and substituting the amount "£2 0s. 0d.":
 - (c) By omitting from item 1c the amount "£0 15s. 0d." and substituting the amount "£2 0s. 0d.":
 - (d) By omitting from item 1D the amount "£0 15s. 0d.", and substituting the amount "£2 0s. 0d.":
 - (e) By omitting from item 1p the words "exceed £15", and substituting the words "exceed £40":
 - (f) By omitting from item 11 the amount "£2 0s. 0d.", and substituting the amount "£4 0s. 0d.":
 - (g) By omitting from item 11a the amount "£2 0s. 0d.", and substituting the amount "£4 0s. 0d.":
 - (h) By omitting from item 11A the amount "£0 2s. 0d.", and substituting the amount "£0 4s. 0d.":
 - (i) By omitting from item 11B the amount "£2 0s. 0d.", and substituting the amount "£4 0s. 0d.":
 - (j) By omitting from item 11B the words "exceed £40", and substituting the words "exceed £80".

3. Where a fee has been paid on or after the 1st day of September, 1951, according to the scale of fees in force before that date, the Commissioner may accord the date of that payment to any document conditionally upon the balance of the fee, according to the scale of fees in force on and after the 1st day of September, 1951, being paid within such extended time as the Commissioner may allow. No additional fee shall be payable upon any extension of time so allowed.

EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

These regulations increase the fees payable on and after the 1st September, 1951, in respect of applications for registration of trade marks and of renewals of registration of trade marks.
