THE TONGARIRO NATIONAL PARK BYLAWS 1981, AMENDMENT NO. 4

PURSUANT to section 56 of the National Parks Act 1980, the Minister of Conservation hereby makes the following bylaws.

BYLAWS

1. Title and commencement—(1) These bylaws may be cited as the Tongariro National Park Bylaws 1981, Amendment No. 4 and shall be read together with and deemed part of the Tongariro National Park Bylaws 1981* (hereinafter referred to as the principal bylaws).

(2) These bylaws shall come into force on the 28th day after the date of

their notification in the Gazette.

- **2. Interpretation**—(1) Bylaw 2 of the principal bylaws is hereby amended by revoking the definitions of the terms "camp" and "camping site".
- (2) Bylaw 2 is hereby amended by inserting, in the appropriate alphabetical order, the definitions of the following terms:

"'Camp' includes staying overnight in any vehicle or boat:

- "'Camping site' means any area that has been appropriated as a camping site under section 49(1)(d) of the Act or under section 28(1)(i) of the National Parks Act 1952:
- "'Tongariro Northern Circuit track' means the Tongariro Northern Circuit track as defined on a map held in the Tongariro/Taupo conservancy office of the Department of Conservation at Turangi:".
- **3. Conditions on access to certain places**—The principal bylaws are hereby amended by inserting, after bylaw 5, the following bylaw:

"5A. (1) Any person may have access to—

- "(a) The Tongariro Northern Circuit track and all land within 500 metres on either side of that track:
- "(b) The area within 100 metres radius of any hut:

"(c) Any emergency shelter—

subject to the conditions in subclause (2) of this bylaw.

- "(2) No person shall camp in any place or part of any place listed in subclause (1) of this bylaw unless-

 - "(a) That place or that part of the place is a camping site; or "(b) That place is an emergency shelter and that person is camping in that shelter in an emergency."
- 4. Offences—Bylaw 17 of the principal bylaws is hereby amended by omitting the words "bylaw 6 or".
- 5. Revocation of bylaw and First Schedule—Bylaw 6 of the principal bylaws and the First Schedule to the principal bylaws are hereby revoked.
