## THE TONGARIRO NATIONAL PARK BYLAWS 1981, AMENDMENT NO. 2

PURSUANT to section 56 of the National Parks Act 1980, the Minister of Lands hereby makes the following bylaws.

# BYLAWS

1. Title and commencement—(1) These bylaws may be cited as the Tongariro National Park Bylaws 1981, Amendment No. 2, and shall be read together with and deemed part of the Tongariro National Park Bylaws 1981\* (hereinafter referred to as the principal bylaws).

(2) These bylaws shall come into force on the day after the date of their notification in the *Gazette*.

2. Parking during winter season at Iwikau Village and Whakapapa Village—The principal bylaws are hereby amended by revoking bylaws 11B and 11c (as inserted by bylaw 3 of the Tongariro National Park Bylaws 1981, Amendment No. 1), and substituting the following bylaws:

"11B. Season parking tickets—The Department may issue a season parking ticket in respect of any motor vehicle that is not a passenger service vehicle on payment to it of the appropriate charge set out in the Second Schedule to these bylaws.

"11c. Display of daily and season parking tickets—(1) Every person who parks or leaves parked a passenger service vehicle in a parking place at Iwikau Village or Whakapapa Village at any time between the hours of 10 a.m. and 5 p.m. on any day during the winter season shall ensure that there is displayed on the front windscreen or dashboard a current daily parking ticket issued for that vehicle.

"(2) Every person who parks or leaves parked any motor vehicle that is not a passenger service vehicle in a parking place at Iwikau Village at any time between the hours of 10 a.m. and 5 p.m. on any day during the winter

season shall ensure that there is displayed on the front windscreen or dashboard either a current season parking ticket issued for that vehicle or a current daily parking ticket issued for that vehicle."

**3. New Second Schedule substituted**—(1) The principal bylaws are hereby amended by revoking the Second Schedule (as added by clause 6 of the Tongariro National Park Bylaws 1981, Amendment No. 1), and substituting the Second Schedule set out in the Schedule to these bylaws.

(2) Clause 6 of and the Schedule to the Tongariro National Park Bylaws 1981, Amendment No. 1 are hereby consequentially revoked.

#### EXPLANATORY NOTE

This note is not part of the bylaws, but is intended to indicate their general effect.

These bylaws increase the parking charges at Iwikau and Whakapapa Villages during the winter season, and abolish some categories of charges.

Season parking charges for passenger service vehicles are abolished.

The daily charge for parking passenger service vehicles at Iwikau Village is increased from \$6 to \$8, and at Whakapapa Village from \$3 to \$4. The daily charge for other motor vehicles is increased from \$3 to \$4. This charge applies at Iwikau Village only.

The system where 2 vehicles could be included on the one season ticket is abolished, and the season parking charge for vehicles other than passenger service vehicles is set at \$60. Previously it was \$30 for 1 vehicle or \$40 for 2 vehicles.
