**THE TRANSPORT (CONVENTION ON ROAD TRAFFIC)  
REGULATIONS 1958, AMENDMENT NO. 2**

ORDER IN COUNCIL

At the Government Buildings at Wellington this 25th day of March 1974

THE HON. H. WATT PRESIDING IN COUNCIL

PURSUANT to the Transport Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Transport (Convention on Road Traffic) Regulations 1958, Amendment No. 2, and shall be read together with and deemed part of the Transport (Convention on Road Traffic) Regulations 1958\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of April 1974.

**2. Interpretation**—(1) Regulation 2 of the principal regulations is hereby amended by inserting, in their appropriate alphabetical order, the following definitions:

“‘Accident compensation levy’ means a levy payable pursuant to section 98 of the Accident Compensation Act 1972:

“‘Indemnity surcharge’ means the indemnity surcharge payable pursuant to part VIA of the Transport Act 1962 (as inserted by section 7 of the Transport Amendment Act 1973).”

(2) Regulation 2 of the principal regulations is hereby further amended by revoking the definition of the term “‘The Act’”, and substituting the following definition:

“‘The Act’ means the Transport Act 1962:”.

**3. Exemption of visitors' vehicles**—Regulation 3 of the principal regulations is hereby amended—

- (a) By omitting from subclause (1) the words "section 15", and substituting the words "section 7":
- (b) By omitting from subclause (2) the words "regulation 12", and substituting the words "regulation 14":
- (c) By omitting from subclause (2) the words "Motor Vehicles Registration and Licensing Regulations 1949" wherever they occur, and substituting in each case the words "Motor Vehicles Registration and Licensing Regulations 1965".

**4. Accident compensation levy and indemnity surcharge**—The principal regulations are hereby further amended by revoking regulation 4, and substituting the following regulation:

"4. (1) There shall be payable in respect of a visitor's motor vehicle upon its arrival in New Zealand and in respect of each licensing year during which that motor vehicle remains in New Zealand an accident compensation levy at the rate prescribed pursuant to section 99 of the Accident Compensation Act 1972 and an indemnity surcharge prescribed pursuant to section 90. of the Transport Act 1962.

"(2) The visitor shall, at the same time as the accident compensation levy is paid, supply to the Deputy Registrar of Motor Vehicles an address in New Zealand care of a bank or an automobile association or any office of the Tourist and Publicity Department or any other address which a Deputy Registrar may approve."

#### EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations are consequential on the provisions of the Accident Compensation Act 1972, and substitute references to the accident compensation levy and the indemnity surcharge for references to third-party risks insurance.

Regulations 2 (1) and 3 are minor drafting amendments only, substituting references to the 1962 Act for references to the repealed 1949 Act and references to the 1965 regulations for references to revoked 1949 regulations.
